#### **OKANOGAN COUNTY COMMISSIONERS'**

#### RESOLUTION 50 - 2023

A resolution in the matter of declaring certain county-owned property surplus to the needs of the county and ordering the sale thereof via public auction sale by either electronic media or by physical auction sale to be located at the county fairgrounds.

WHEREAS, in accordance with Revised Code of Washington 36.34 the Board of Okanogan County Commissioners proposes to conduct a public hearing to hear a proposal to dispose of county owned property and admit evidence for and against the proposed action and designate the sale to be conducted via public auction sale by electronic media; and

WHEREAS, in accordance with RCW 36.34 legal notice postings and advertisements have been made and published for two consecutive weeks in the April 5-6, and April 12-13, 2023, editions of the Gazette Tribune/Methow Valley News, which are the county's legal newspaper of record, with publication setting forth the hearing date of April 18, 2023 at 1:30 p.m. The BOCC held the hearing at that time and then continued to April 24, 2023 at 1:30 p.m., to provide time for both written and verbal testimony to be taken from the public on whether or not the property proposed for sale is surplus to the County's needs to be sold at public surplus auction; and

WHEREAS, once the items have been declared surplus to the needs of Okanogan County it is the intention of Okanogan County to sell the items via public surplus auction sale by either electronic media or by physical public auction.

**NOW THEREFORE, BE IT FURTHER RESOLVED,** that the Board of Okanogan County Commissioners' hereby declares items described and listed as Attachment "A" surplus to the needs of the county and orders all listed items sold to the highest bidder at a sale to be conducted via public surplus auction sale by either electronic media in accordance with RCW 36.14.145 or by physical surplus auction.

**BE IT FURTHER RESOLVED,** the Board of Okanogan County Commissioners' hereby sets the physical surplus auction date to be Saturday, May 13, 2023 to be held at the Okanogan County Fairgrounds.

**BE IT FURTHER RESOLVED**, that proceeds from the sales are to be credited to the fund from which the original purchase price was paid.

**BE IT FURTHER RESOLVED,** surplus items that do not sell at public surplus auction are hereby authorized to be disposed of in the most economical and cost-effective method.
