Resolution No. 54 - 2021

WHEREAS, IT IS HEREBY RESOLVED THAT **Rendezvous Road**, State Road Log No. 12230 from milepost 0.058 to milepost 0.550 be improved as follows:

This project will improve the road surface on Rendezvous Road from BMP 0.000 to EMP 0.500 by widening shoulders, applying recycled asphalt and a double shot of Bituminous Surface Treatment. One existing culvert will be replaced and one new culvert installed. This work will be accomplished by County Forces.

This project is hereby declared to be a public necessity and the County Road Engineer is hereby ordered and authorized to report and proceed thereon as by law provided. (RCW 36.75.050, 36.80.030, 36.80.070)

NOW, THEREFORE, BE IT FURTHER RESOLVED that an appropriation from the officially adopted road fund budget and based on the County Engineer's estimate is hereby made in the amounts and for the purposes shown:



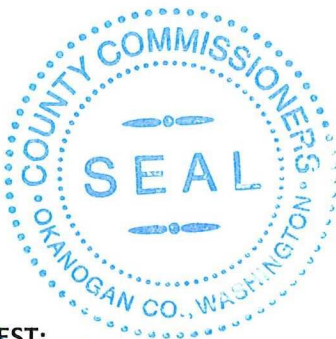


