Resolution No. 56 - 2022

WHEREAS, IT IS HEREBY RESOLVED THAT **Chiliwist Road**, State Road Log No. 18820 from milepost 1.945 to milepost 2.745 be improved as follows:

This project will improve the road surface on Chiliwist Road from BMP 1.945 to EMP 2.745 by widening shoulders, applying base course, top course and a double shot of Bituminous Surface Treatment. This work will be accomplished by County Forces.

This project is hereby declared to be a public necessity and the County Road Engineer is hereby ordered and authorized to report and proceed thereon as by law provided. (RCW 36.75.050, 36.80.030, 36.80.070)

NOW, THEREFORE, BE IT FURTHER RESOLVED that an appropriation from the officially adopted road fund budget and based on the County Engineer's estimate is hereby made in the amounts and for the purposes shown:


