 PROJECT DESIGNATED AS CRP NO. 9425-26 **Resolution No. 61- 2021**

WHEREAS, IT IS HEREBY RESOLVED THAT Loomis Oroville Road, State Road Log No. 94250 from milepost 0.280 to milepost 0.660 be repaired as follows:

This project is a DR (Drainage Structure) project which will include the replacement of 3 old deteriorated 30" culvert. The new culverts are estimated to be 36" CMP culverts. The road surface will be repaved at each culvert location and minor guardrail modifications maybe required to accommodate the new culverts.

This project is hereby declared to be a public necessity and the County Road Engineer is hereby ordered and authorized to report and proceed thereon as by law provided. (RCW 36.75.050, 36.80.030, 36.80.070)

NOW, THEREFORE, BE IT FURTHER RESOLVED that an appropriation from the officially adopted road fund budget and based on the County Engineer's estimate is hereby made in the amounts and for the purposes shown:


