**RESOLUTION 77 - 2022** 

A resolution in the matter of declaring certain county-owned property surplus to the needs of the county and ordering the sale thereof via public auction sale by either electronic media or by physical auction sale.

WHEREAS, in accordance with Revised Code of Washington 36.16 the Board of Okanogan County Commissioners proposes to conduct a public hearing to hear a proposal to dispose of county owned property and admit evidence for and against the proposed action and designate the sale to be conducted via public auction sale by electronic media; and

WHEREAS, in accordance with RCW 36.34 legal notice postings and advertisements have been made and published for two consecutive weeks in the May 25 and 26, and June 1 and 2, 2022, editions of the Methow Valley News and Gazette Tribune, which constitutes the county's legal newspaper of record, with publication setting forth the date, time, and place of the Public Hearing; and,

WHEREAS, said public hearing was conducted by the Board of Okanogan County Commissioners on June 7 at 2:00 p.m., this time was provided for both written and verbal testimony to be taken from the public on whether or not the property proposed for sale is surplus to the County's needs and should be sold via public auction sale by electronic media; and

**WHEREAS**, once the items have been declared surplus to the needs of Okanogan County, it is the intention of Okanogan County to sell the items via public auction sale by electronic media; and

**NOW THEREFORE, BE IT FURTHER RESOLVED,** that the Board of Okanogan County Commissioners' hereby acknowledges the attached list of surplus items as Attachment "A" and declares items described and listed as Attachment "A" surplus to the needs of the county and orders all listed items sold to the highest bidder at a sale to be conducted via public auction sale by electronic media in accordance with RCW 36.16.145 or by physical surplus auction.

**BE IT FURTHER RESOLVED,** that proceeds from the sales are to be credited to the fund from which the original purchase price was paid.
