**WHEREAS, IT IS HEREBY RESOLVED THAT Loup Loup Canyon Road, State Road Log No. 2045 at milepost 5.029 be improved as follows:**

This project will include installing a Creek Guard that is 16' x 20' across the over flow area of the Loup Loup Creek.

This project is hereby declared to be a public necessity and the County Road Engineer is hereby ordered and authorized to report and proceed thereon as by law provided. (RCW 36.75.050, 36.80.030, 36.80.070)




