Resolution No. 93 - 2021

WHEREAS, IT IS HEREBY RESOLVED THAT **Aeneas Valley Road**, State Road Log No. **94550** at milepost 10.989 be improved as follows:

This project will include replacing the failing 4' culvert at 10.989 with a 9' squash pipe as requested by Washington State Department of Fish and Wildlife. The road will need to be elevated slightly to accommodate the larger culvert and the super of the corner will need to be re-engineered. The roadway will then be repaved.

This project is hereby declared to be a public necessity and the County Road Engineer is hereby ordered and authorized to report and proceed thereon as by law provided. (RCW 36.75.050, 36.80.030, 36.80.070)

NOW, THEREFORE, BE IT FURTHER RESOLVED that an appropriation from the officially adopted road fund budget and based on the County Engineer's estimate is hereby made in the amounts and for the purposes shown:
