A resolution authorizing a budget supplemental appropriation within the Emergency Management Fund 121 for expenditures related to Grant E22-230 for emergency vehicle equipment

**WHEREAS**, the Board of Okanogan County Commissioners (BOCC) approved the County's 2023 Current Expense budget including Public Works, Special, and Miscellaneous fund budgets via resolution 192-2022; and
