**RESOLUTION 102 - 2022**

*A resolution authorizing a budget supplemental appropriation within the Current Expense USD/BLM PILT fund and Water Conservancy Board fund 139 in the amount of \$5,000*

**WHEREAS**, the Board of Okanogan County Commissioners (BOCC) approved the County's 2022 Current Expense budget including Public Works, Special, and Miscellaneous fund budgets via resolution 157-2021; and

**WHEREAS**, Okanogan County Water Conservancy Board collects application fees which do not cover the total cost of administering the paperwork and board functions; and

**WHEREAS**, the BOCC wish to support the functions of the Water Conservancy Board; and
