

OKANOGAN COUNTY COMMISSIONERS'
RESOLUTION 105-2022

A resolution adopting a Fair Vendor fee schedule for consistent Fair Booth Fees.

WHEREAS: Okanogan County owns and operates a facility located on the Okanogan County Fairgrounds, and

WHEREAS: The Okanogan Board of County Commissioners (BOCC) finds that it serves the public interest to make the facility, in whole or in part, available for use by the public and provide vendor booth space for the various types of vending at the county fair, and

WHEREAS: The Washington State Constitution states in Article VIII SECTION 7 CREDIT NOT TO BE LOANED- No county, city, town or other municipal corporation shall hereafter give any money, or property, or loan its money, or credit to or in aid of any individual, association, company or corporation, except for the necessary support of the poor and infirm, or become directly or indirectly the owner of any stock in or bonds of any association, company or corporation

WHEREAS: The BOCC has determined the attached fee schedule charges compensation for the use of the facility during the fair that covers the cost of operating the facility for the event, and

BE IT THEREFORE RESOLVED:

1) The Okanogan Board of County Commissioners hereby adopts the attached Fair Vendor Fee Schedule as Attachment A.


