*A resolution authorizing a budget supplemental appropriation within the Sheriff's Special Projects fund 124 in the amount of \$168,117*

**WHEREAS**, the Board of Okanogan County Commissioners (BOCC) approved the County's 2021 Current Expense budget including Special and Miscellaneous fund budgets via resolution 183-2020; and

**WHEREAS**, the Sheriff must utilize state legislature distributed funds specific for the funding of law enforcement reform costs; and

**WHEREAS**, it is necessary to appropriate budget to cover the expenditures so that the Sheriff can meet the reform requirements; and

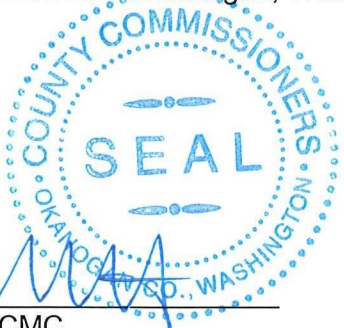
