**WHEREAS, IT IS HEREBY RESOLVED THAT Twisp River Road, State Road Log No. 91140 from milepost 1.287 to milepost 1.307 be repaired as follows:**

This project is a BR (Bridge Repair) project which will include repairing the deck surface and replace the failed paint on the steel girders

This project is hereby declared to be a public necessity and the County Road Engineer is hereby ordered and authorized to report and proceed thereon as by law provided. (RCW 36.75.050, 36.80.030, 36.80.070)


