This project is a STP(R) funded project which will complete and HMA overlay and pavement repair as needed will restore surface to satisfactory condition. Guardrail may need to be reset to proper height after HMA overlay in placed

This project is hereby declared to be a public necessity and the County Road Engineer is hereby ordered and authorized to report and proceed thereon as by law provided. (RCW 36.75.050, 36.80.030, 36.80.070)


