RESOLUTION 115-2022

A Resolution regarding the adoption of a revised Okanogan County Fairgrounds rental rate fee schedule

WHEREAS: Okanogan County owns and operates the Okanogan County Fairgrounds, and

WHEREAS: The Board of Okanogan County Commissioners' (BOCC) finds that it serves the public interest to make the facility, in whole or in part, available for use by the public, and

WHEREAS: Consistent with the State Constitution a public agency should generally receive some sort of compensation for the use of its facilities to avoid an improper gift of public funds. At a minimum, the fee or rental charge should at least cover the cost of operating the facility for the event (maintenance, utilities, staffing, etc.).

WHEREAS: The BOCC adopted resolution 20-2021 approving an illustrated basic facility rental rate and fee schedule, and

WHEREAS: The BOCC directed staff to prepare a revised fee schedule to include language for reduced fees and fee waivers and options for an illustrative pamphlet,

BE IT THEREFORE RESOLVED: The fee schedule adopted by resolution 20-2021 is hereby rescinded in its entirety, and

BE IT FURTHER RESOLVED: The Okanogan County Board of Commissioners hereby adopts a revised fee schedule for the use of the Fairgrounds Facility found as Attachment A to this resolution effective upon date of adoption; and

BE IT FURTHER RESOLVED: the fees adopted by this resolution may be duplicated in a different format or pamphlet using illustrations of rental facilities with instructions and details needed for events for public use.

PLEASE NOTE: Basic rental includes a ½ day set up and ½ day cleanup and included in rental rate. A damage/cleaning deposit is required. The deposit is refundable if the facilities used are left in an acceptable condition as determined by fairgrounds staff.

DEPARTMENTAL FEE REDUCTIONS: The Board of Okanogan County Commissioners authorizes the use of the Fairgrounds smaller buildings such as the Annex/Kitchen and Jones Hall buildings by County Departments for a county business related function at a cost of \$75 per day as long as the facility is not already reserved.

FEE WAIVER: Per the Washington State Constitution- gift of public funds doctrine Article 8, Section 7 and Section 5, the BOCC may waive the fee for use of the facilities upon a request by any private non-profit or public organization that seeks to use the facility, in whole or in part, for an event that directly serves the poor and infirm. The request must include a detailed explanation as to how the organization delivers service to a qualifying group of people. (The BOCC defines the terms infirm and poor as: 1) infirm: not physically or mentally strong, especially through age or illness, 2) poor: lacking sufficient money to live at a standard considered comfortable or normal in a society.)

The BOCC may waive the fee for an event of community-wide importance, which can include but not be limited to funerals, community informational meetings (other than political gatherings), and memorials. The BOCC shall not waive any fee for any event where the organizers are charging a fee for entry or any service, accepting donations to cover or partially cover expenses, or accepting sponsors to cover or partially cover expenses.

CHANGE OF VENUE: In the event that the County deems it necessary to move an event to a building with a higher cost, the renter would not be required to pay the higher fee amount.
