WHEREAS, On July 25, 2023, the Board of Okanogan County Commissioners (BOCC) contracted with EC Touring, Inc (Easton Corbin) for entertainment at the upcoming 2023 Okanogan County Fair; and

WHEREAS, said contract includes an agreement (XVII Catering) to provide meals for entertainers and support staff that includes a "buyout" option"; and

WHEREAS, leadership in the Fair Advisory Committee negotiated a cash buyout that reduced the County obligation; and

WHEREAS, in order to render such payment, the Auditor and Treasurer's offices need a means to make said payment in cash.

NOW THEREFORE BE IT RESOLVED, that the BOCC directs the County Auditor to issue a check in the amount of \$675 to the County Treasurer to convert to cash to be provided to the Fairgrounds Manager for payment at "load-in" as specified in the subject contract (pro ion attached).
