

**OKANOGAN COUNTY COMMISSIONERS'**

**RESOLUTION 131 - 2020**

*A resolution authorizing a budget supplemental appropriation within the BECCA fund 113 and Law Library fund 108 and Current Expense Juvenile and Contingency Reserve.*

**WHEREAS**, the Board of Okanogan County Commissioners (BOCC) approved the County's 2020 Current Expense budget including Special and Miscellaneous fund budgets via resolution 156-2019 as amended by resolution 169-2019; and

**WHEREAS**, the Juvenile Department received additional funds from the State Administrative Office of the Courts that need to be budgeted as additional revenue and expenditures; and

**WHEREAS**, the Law Library fund has received less revenue due to reduced fees due to COVID-19, but it has expenditure obligations that must be provided for, and

**WHEREAS**, a Public Hearing was first set on said supplemental appropriation on October 6, 2020, at 11:55 a.m. then continued to 11:55 a.m. to hear public testimony for or against the budget supplemental; and

**WHEREAS**, a notice of said hearing was published in the official legal newspaper of Okanogan County, as required by law;


