OKANOGAN COUNTY COMMISSIONERS RESOLUTION NO. 137 - 2021

A resolution adopting a revised fee schedule for the Okanogan County Office of Planning and Development.

WHEREAS, While RCW 82.02.020 preempts for the State certain tax fields, it further states that "Nothing in this section prohibits cities, towns, counties, or other municipal corporations from collecting reasonable fees from an applicant for a permit or other governmental approval to cover the cost to the city, town, county, or other municipal corporation of processing application, inspecting, and reviewing plans, or preparing detailed statements required by chapter 43.21C RCW, including reasonable fees that are consistent with RCW 43.21C.420(6), and beginning July 1, 2014, RCW 35.91.020"; and,

WHEREAS, Okanogan County has adopted a schedule of fees to cover or nearly cover the cost of processing land use applications; and,

WHEREAS, Okanogan County Code Title 20 was adopted in part in response to Whatcom-Hirst decision has imposed new permit processes to determine the ability of land owners to legally and physically use a permit exempt well as a source of potable water; and,

WHEREAS, the cost of advertising notices, supplies, materials, and resources has increases substantially in the past year and a half; and,

WHEREAS, Staff review of the current fee schedule has determined that it does not recover the cost of staff review, notifications, hearings, and publication of required notices; and,

NOW, THEREFORE, BE IT RESOLVED that the Okanogan County Board of County Commissioners hereby approves the revised fee schedule attached to this resolution; and,

BE IT FURTHER RESOLVED the Okanogan County Board of County Commissioners finds it in the interest of the public to immediately implement the new fee schedule; and

BE IT FURTHER RESOLVED that all applications for land use activities and other services shown on the attached fee schedule provided the Office of Planning and Development/GIS department received or postmarked after November 1, 2021 will be subject to the revised fee schedule adopted by this resolution.

Wetland Rating

A \$32/hour rate fee will be applied to all wetland delineation processes that exceed 4 hours. The County may require that the applicant hire an approved/certified specialist to provide required analysis/report in which case only the costs associated with the County's report(s) review will be assessed.

Mileage

Mileage rates are variable according to the current rate set by the Board of Okanogan County Commissioners.

Other Fees

Other fees required in conjunction with the above applications (i.e. taxes, recording fees, etc.) are not included.

Fees Not Required

Applications initiated by the Board of Okanogan County Commissioners, Okanogan County Planning Commission, and the Office of Planning and Development are exempt from application fees.

Refund Policy

The Okanogan County Office of Planning and Development may refund all or a portion of fees paid as outlined and required by the Fee Schedule if the application is withdrawn within 7-days of vesting of the application. The application fee less costs incurred to that date by Okanogan County may be refunded, as determined by the Planning Director. Only those fees required by the Okanogan County Office of Planning & Development may be considered for refund by the Okanogan County office of Planning & Development.
