

**OKANOGAN COUNTY COMMISSIONERS'**

**RESOLUTION 140 – 2021**

*A resolution authorizing a budget supplemental appropriation within the Fair Fund 112 in the amount of \$18,500 and Real Estate Excise Tax Fund 144 in the amount of \$25,000*

**WHEREAS**, the Board of Okanogan County Commissioners (BOCC) approved the County's 2021 Current Expense budget including Special and Miscellaneous fund budgets via resolution 183-2020; and

**WHEREAS**, the Fair had unexpected costs associated with fair race and rodeo production, premium points and Treasurer's office overtime for fair services; and

**WHEREAS**, the Auditor approved use of REET funds for Assessor's office document preservation project which must be budgeted for expenditure; and

**WHEREAS**, a Public Hearing was first set on said budget supplemental appropriation on November 9, 2021 at 4:25 p.m. to hear public testimony for or against the supplemental; and

**WHEREAS**, a notice of said hearing was published in the official legal newspaper of Okanogan County, as required by law;
