

OKANOGAN COUNTY COMMISSIONERS'

RESOLUTION 147 - 2020

A resolution authorizing a budget supplemental appropriation within Current Expense Sheriff and Current Expense Jail.

WHEREAS, the Board of Okanogan County Commissioners (BOCC) approved the County's 2020 Current Expense budget including Special and Miscellaneous fund budgets via resolution 156-2019 as amended by resolution 169-2019; and

WHEREAS, the Okanogan County Sheriff's Office received a supplemental Stone Garden Grant Award that must be budgeted for expending; and

WHEREAS, the Okanogan County Sheriff requested the purchase of body worn cameras for Patrol and Corrections Division as Sheriff's employees require constant personal interaction with individuals and public within the Corrections center which increases risk for transmission of the COVID-19 disease; and

WHEREAS, Employees equipped with the body mounted cameras will facilitate compliance with COVID-19 public safety measures through physical distancing and minimization of time spent in required personal interactions with residents and visitors of the county, and

WHEREAS, the Board of County Commissioners supports the safety needs of the Department and deems the purchase an important and necessary tool to facilitate compliance with public health and safety measures; and


WHEREAS, a Public Hearing was first set on said supplemental appropriation on November 3, 2020, at 3:40 p.m. to hear public testimony for or against the budget supplemental; and


WHEREAS, a notice of said hearing was published in the official legal newspaper of Okanogan County, as required by law;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Okanogan County Commissioners, that the following budget Supplemental Appropriation within Current Expense Sheriff and Current Expense Jail fund as listed below is hereby authorized as follows:
