**RESOLUTION 147 - 2023**

*A resolution authorizing a budget supplemental appropriation within Contingency Reserve and Current Expense Investment Interest in the amount of \$320,000*

**WHEREAS**, the Board of Okanogan County Commissioners (BOCC) approved the County's 2023 Current Expense budget including Public Works, Special, and Miscellaneous fund budgets via resolution 192-2022; and

**WHEREAS**, several county funds had unexpected expenditures due to increased cost of doing business or due to BOCC approved expenses that were not previously budgeted for; and

**WHEREAS**, it is necessary to provide sufficient budget for the needs of county functions; and

**WHEREAS**, a Public Hearing was first set on said budget supplemental appropriation on November 6, 2023, 4:15 p.m. to hear public testimony for or against the supplemental and a notice of said hearing was published in the official legal newspaper of Okanogan County, as required by law; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Okanogan County Commissioners that the following BARS lines shall be supplemented and appropriated as conveyed below:

The county auditor shall issue no warrant and the county commissioners shall approve no claim for any expenditure in excess of the detailed budget appropriations or as revised under the provisions of RCW 36.40.100 through 36.40.130, except upon an order of a court of competent jurisdiction, or for emergencies as hereinafter provided.
