OKANOGAN COUNTY COMMISSIONERS' RESOLUTION 156 - 2020

A resolution authorizing a budget supplemental appropriation within Public Works Road fund 102 & Solid Waste fund 405

WHEREAS, the Board of Okanogan County Commissioners (BOCC) approved the County's 2020 Current Expense budget including Special and Miscellaneous fund budgets via resolution 156-2019 as amended by resolution 169-2019; and

WHEREAS, the Okanogan County Public Works ER&R received an invoice that would have normally have been paid in 2019 but was paid in 2020; and

WHEREAS, it was not known that the invoice would be paid in 2020 when the county adopted its 2020 budget in 2019 which resulted in a larger 2020 beginning fund balance and also higher expenditures in many activities within the Road and Solid Waste funds; and

WHEREAS, no penalties or additional costs were incurred overall, but the budget supplemental is required in order to provide the budgeted expenditures for 2020 services at the level intended during the budget process and

WHEREAS, a Public Hearing was first set on said supplemental appropriation on November 17, 2020, at 10:55 a.m. to hear public testimony for or against the budget supplemental; and

WHEREAS, a notice of said hearing was published in the official legal newspaper of Okanogan County, as required by law;
