# OKANOGAN COUNTY COMMISSIONERS' RESOLUTION 157 - 2022

### ORDER ANNEXING LANDS WITHIN OKANOGAN COUNTY RURAL FIRE POTECTION DISTRICT NUMBER 1

WHEREAS, a signed petition was received by Fire Protection District No. 1 petitioning the district to annex certain lands adjacent to the district into its district boundaries; and

WHEREAS, Fire Protection District No. 1 held at a regular meeting on September 9, 2022, at which time said Fire District Commissioners adopted a resolution dated September 13, 2022 in concurrence of the annexation request of such properties into the district; and

**WHEREAS**, said petition signatures were reviewed by the County Auditor's office and a certificate of sufficiency was supplied certifying that at least 60% of the qualified registered electors, within the proposed area, signed the petition; and

WHEREAS, the real property descriptions and plat maps of the property to be annexed were reviewed and a determination of sufficiency was provided by the Assessor's Drafting Supervisor; and

WHEREAS, RCW 52.04.011 (3) states in part, "if the petition is signed by 60% of the qualified registered electors residing within the territory proposed to be annexed, and if the board of fire commissioners concur, an election in the territory and a hearing on the petition shall be dispensed with and the county legislative authority shall enter its record an order incorporating the territory into the existing fire protection district."

**NOW THEREFORE BE IT RESOLVED,** that the Board of Okanogan County Commissioners hereby orders and designates the following lands, as attached and described hereto as Attachment "A", to be incorporated into the territory of the existing Okanogan County Rural Fire Protection District No. 1.

**BE IT FURTHER RESOLVED**, upon the entry of the order incorporating the territory into the existing fire protection district, the territory shall become subject to the indebtedness, bonded or otherwise of the existing district.





### RCW 52.04.031

### Annexation by petition method—Petition—Signers—Content.

A petition for annexation of an area located within reasonable proximity to a fire district shall be in writing, addressed to and filed with the board of fire commissioners of the district to which annexation is desired. Such territory may be located in a county or counties other than the county or counties within which the fire protection district is located. It must be signed by the owners, according to the records of the county auditor or auditors, of not less than sixty percent of the area of land included in the annexation petition, shall set forth a legal description of the property and shall be accompanied by a plat which outlines the boundaries of the property to be annexed. The petition shall state the financial obligation, if any, to be assumed by the area to be annexed.

The petition contains valid signatures of the property owners, Christie Parker and Jesse Pecoraro, who own all three parcels to be annexed. Which is sufficient for this petition.
