A RESOLUTION OF THE OKANOGAN BOARD OF COUNTY COMMISSIONERS
CERTIFYING THE SPECIAL ASSESSMENT ROLLS FOR LAKE MANAGEMENT DISTRICT #1
LOCATED ADJACENT TO LAKE OSOYOOS IN OKANOGAN COUNTY WASHINGTON.

WHEREAS: RCW 36.61.020 allows the Board of County Commissioners by resolution to announce its intent to create a Lake Management District to finance certain authorized activities and which must be approved by the property owners through a ballot measure in accordance with RCW 36.61.070, and

WHEREAS: The BOCC found a simple majority of the ballots cast were in favor of forming Lake Management District #1 and adopted Ordinance 2018-014 on August 28, 2018 which authorized the formation of Lake Management District #1 and the levying of a special assessment of \$160.00 per parcel on the parcels within the district, and

WHEREAS: On December 14, 2019 Resolution 175-2020 certified the special assessment roll for Lake Management District #1 located adjacent to Lake Osoyoos in Okanogan County, and

WHEREAS: Objections to the assessment were received by impacted landowners, and

WHEREAS: A public hearing was scheduled on December 13, 2021 by the BOCC to hear one objection from a landowner and three adjustments warranted by a boundary line adjustment to the special assessment rolls, and

WHEREAS: Notice of the hearing was published on December 2nd and 9th, 2021, and

WHEREAS: The BOCC conducted the public hearing on December 13, 2021 and reviewed one objection filed by a landowner and three adjustments warranted by a boundary line adjustment, and

WHEREAS: After review of the information submitted, the BOCC took the following actions:

- 1. Remove parcel #4027150051, belonging to Philip & Debra Unger; this parcel number was retired due to Boundary Line Adjustment #3248360.
- 2. Remove parcel #6400330009, belonging to Philip & Debra Unger; this parcel number was retired due to Boundary Line Adjustment #3248360.
- 3. Add the following parcels which were created by Boundary Line Adjustment #3248360:
- a. 8883100100, belonging to Nathan & Laurie Ukrainetz
- b. 8883100200, belonging to Colin Van Den Brink
- c. 8883100300, belonging to Philip & Debra Unger

WHEREAS: After ruling on all objections received prior to the hearing and ordering amendments to the special assessment rolls the BOCC ordered the Director of Planning to prepare a resolution certifying the special assessment roll as amended and corrected,
