RESOLUTION 2 – 2023

A resolution authorizing Oroville Rural Emergency Medical Services Levy to be collected in 2024 and increasing the percentage to be collected as allowed by law

WHEREAS, the Board of Okanogan County Commissioners, as the governing body of the taxing district of Oroville Rural Emergency Medical Services District, has met and considered the Oroville Rural EMS District's budget for the calendar year 2024; and,

WHEREAS, the district's actual levy amount was \$221,302; and,

WHEREAS, the population of this district is less than 10,000.

WHEREAS, a public hearing was held on November 6, 2023, in accordance with RCW 84.55.120, on the district's 2024 budget which is primarily funded by taxes and charges and reflects the provision of ongoing services; and

NOW, THEREFORE BE IT RESOLVED by the governing body of the taxing district that an increase in the regular property tax levy is authorized for the levy to be collected in the 2023 tax year.

The dollar amount of the increase over the actual levy amount from the previous year shall be \$2,213, which is a percentage increase of 1% from the previous year. This amount does not include an increase that would be additional revenue resulting from new construction, improvements to property, newly constructed wind turbines, any increase in the value of state assessed property, any annexations that have occurred, and refunds made.
