Ordinance 2008-3

AN ORDINANCE AMENDING OFFICIAL ZONING MAP FOR OKANOGAN COUNTY ADDING AN ADDITIONAL PLANNED DEVELOPMENT ZONE FOR THE METHOW VALLEY VIEW PLANNED DEVELOPMENT 2008-1.

SECTION 1: FINDINGS AND RECITALS

- 1.1. The applicant proposes a planned development, rezoning approximately 30.16 acres and subdividing 8 lots.
- 1.2. The comprehensive plan designation of the property is "Methow Valley Sub-unit A-4, Rockview/Big Valley".
- 1.3. The zoning designation of the property is "Rural Residential" and "Low-Density Residential" and will become "Planned Development".
- 1.4. A development agreement is proposed, defining the zoning within the planned development.
- 1.5. The property is located within Fire District 6.
- 1.6. This long plat application was initiated under, and subject to, all applicable provisions of Okanogan County Code.
- 1.7. The subdivision process is authorized and outlined in Okanogan County Code, Chapter 16.16, (Pre-application Procedures), 16.20 (Preliminary Plats), and 16.24 (Final Plats).
- 1.8. On February 15, 2008, an application for a Planned Development was submitted. The application was vested on March 14, 2008.
- 1.9. Notice of the application was mailed to commenting agencies on March 18, 2008.
- 1.10. Notice of application and public hearing were mailed to adjacent landowners and interested parties on March 18, 2008.
- 1.11. Notice of application was published in Gazette Tribune (Okanogan County's legal periodical of record) on March 19, 2008, and the Methow Valley News on March 20, 2008.
- 1.12. Notice of public hearing was published in Gazette Tribune (Okanogan County's legal periodical of record) on April 24, 2008, and the Methow Valley News on April 19, 2008.
- 1.13. On March 20, 2008 an environmental threshold (preliminary) Mitigated Determination of Non-Significance was issued. The comment period ended April 7, 2008.
- 1.14. On April 24, 2008 a final Mitigated Determination of Non-Significance was issued. The appeal period ended May 12, 2008.

- 1.15. The Okanogan County Regional Planning Commission conducted a public hearing on May 19, 2008. From this public hearing the Planning Commission offered a recommendation to the Board of Okanogan County Commissioners.
- 1.16. The Board of Okanogan County Commissioners conducted a public hearing in order to review the Planned Development. At this time the Board considered the recommendation of the Okanogan County Regional Planning Commission.

SECTION 2: ZONING MAP AMENDMENT

The Board of Okanogan County Commissioners do hereby ordain as follows:

Based on the Findings and Recitals cited herein, the official Okanogan County Zoning Map is hereby amended as shown in "Attachment A".
