#### ORDINANCE 2012 - 1

#### REVISING THE LEGAL DESCRIPTIONS FOR OKANOGAN COUNTY VOTER PRECINTS AND AMENDING OCC 1.16.010 AND OCC 1.16.020 TO COMPLY WITH CONGRESSIONAL AND LEGISLATIVE RE-DISTRICTING

Whereas, RCW 29A.16.040 allows counties to revise precinct boundaries at any time;

Whereas, the state legislative and federal congressional districts were amended in response to the 2010 census data; and

Whereas, the changes to state and federal districts required changes to the voter precincts in Okanogan County, and

**Whereas,** the Okanogan County Auditor's Office has prepared revised legal descriptions to precincts as deemed necessary;

NOW THEREFORE, the Board of County Commissioners ordains as follows:

Section 1. Amendment. The changes to OCC 1.16.010 Commissioner Districts described in Attachment A are adopted.

Section 2. Amendment. OCC 1.16.020 Voters Precincts shall be amended to reflect the precinct list and legal descriptions described in Attachment B to this ordinance.

Section 3. Effective Date. This ordinance takes effect immediately.

Section 4. Severability. If any provision of this ordinance, or its application to any person, entity or circumstances is for any reason held invalid, the remainder of the ordinance, or the application of the provision to other persons, entities or circumstances is not affected.
