**REPEALING AND AMENDING SECTIONS OF OKANOGAN COUNTY CODE (OCC) 2.04
COUNTY COMMISSIONERS**

WHEREAS, it is necessary and prudent to periodically review, update and revise the Okanogan County Code (OCC), and;

WHEREAS, as required by law, publication of the Public Hearing notice was placed in the newspaper of record and the Board of Okanogan County Commissioners held the Public Hearing on May 14, 2013, and heard all parties interested on said amendments;

WHEREAS, OCC Section 2.04 contains inaccurate, outdated and superfluous sections that should be amended or repealed to reflect current practice and procedure,


NOW, THEREFORE BE IT THEREFORE ORDAINED by the Board of Commissioners for Okanogan County:





EXHIBIT A

2.04.010 Meetings.

The time of regular meetings of the Board of County Commissioners shall be 9:00 a.m. on the Monday and Tuesday of each week, excepting holidays, or as otherwise ordered by the Board. All meetings of the Board shall be held at the county seat unless otherwise ordered by the Board. This section shall be deemed sufficient notice to the public of all regular meetings.

Pursuant to RCW 36.32.090, the county legislative authority may hold special sessions to transact the business of the county, provided notice of the special meeting is made pursuant to RCW 42.30.080 stating the time, the place and the date of holding the session and the business to be transacted.

2.04.020 Minutes – Posting.

The clerk of the board shall post the minutes of the commissioners' proceedings on the official county website located at <http://www.okanogancounty.org/Commissioners/index.html>.

2.04.040 Reimbursement of State Association.

The Washington State Association of Counties shall be reimbursed, within the statutory annual limitation, for any expenses incident to such services when duly prepared vouchers are submitted to the county auditor and approved by the board in the manner provided by law for disbursement of the current expense fund of the county.

2.04.050 Clerk of Board.

A. The clerk of the board of Okanogon County commissioners shall be directly employed by and serve at the pleasure of the commissioners.

B. Agent to Receive Claims for Damages. The clerk of the board is appointed as agent to receive all claims for damages made under RCW 4.96. Standard tort claim forms are available from the office of the County Commissioners and online at http://www.okanogancounty.org/Commissioners/Cmrs/claim_for_damages.htm.
