ORDINANCE 2021-5

An Ordinance repealing a section (2.66 Oroville Regional Planning Advisory Committee) of Okanogan County Code (OCC) Title 2, Administration and Personnel as it relates to the creation of an Oroville Regional Planning Advisory Committee.

WHEREAS, The Washington State Legislature adopted Revised Code of Washington (RCW) 36.70.060 authorizes the County to join with one or more cities and towns, port districts, or any other private or public organization interested in regional planning to form and organize a regional planning commission and provide for the administration of its affairs.

WHEREAS, the Oroville Regional Planning Advisory Committee was created in 1986 by Okanogan County Commissioners Resolution 63-86, and

WHEREAS, the Oroville Regional Planning Advisory Committee has dissolved and not met for a number of years, and

WHEREAS, the geographically located area contiguous to the City of Oroville which provides the economy and residences of Oroville's citizens, but, which is outside the city limits of Oroville is designated as "regional" in OCC, and

WHEREAS, the Oroville Regional Planning Advisory Committee was created to provide the Oroville City Council with those planning functions needed by the City Council from time to time as necessary fact-finding support for decisions of the County, and

WHEREAS, Okanogan County currently has a regional planning commission commonly known as the Okanogan County Regional Planning Commission, and

WHEREAS, the Okanogan County Regional Planning Commission has two members who represent District 3 which includes the greater Oroville area, and

WHEREAS, a review of OCC shows that the Okanogan County Regional Planning Commission has absorbed the duties assigned to the Oroville Regional Planning Advisory Committee, and

WHEREAS, the Okanogan County Board of County Commissioners finds it will benefit the public and use of public funds to repeal OCC 2.66, Oroville Regional Planning Advisory Committee, and

BE IT THEREFORE ORDAINED, Okanogan County Code 2.66 and resolution 63-86 is hereby repealed.

COMMISSIONERS' RESOLUTION #63-86

RESOLUTION

A RESOLUTION TO PROVIDE COUNTY PLANNING FOR THE NORTH OKANOGAN REGION OF OKANOGAN COUNTY:

WHEREAS, the economic basis of the city and county areas are directly related to the commercial and industrial business located within that area, and;

WHEREAS, the commercial and industrial businesses of the city and county areas is the direct concern and responsibility of the city and County Governments, and;

WHEREAS, the income of the city and county governments is derived from assessment and taxation revenues of the residential, commercial, and industrial economic base of the city and county, and;

WHEREAS, the business attitudes and environment within the city and county areas is the direct responsibility of that city and county government, and;

WHEREAS, the commercial and industrial activity within the city and county areas is controlled by city and county ordinances, and;

WHEREAS, the development of commercial and industrial ordinances specify what business may be conducted, how it can function within the area, and generally outline where a business activity is conducted, and;

WHEREAS, the orderly development requires that the location and appeal of each commercial and industrial business be planned to be compatible to its environment so as to preserve the positive and desirable values of the community within the city and county areas, and;

WHEREAS, it is necessary to provide objectives and goals for development and to schedule those goals as a new image of Oroville and the region in increments of five, ten and twenty years from now as a coordinated program of achievment.

NOW, THEREFORE, BE IT RESOLVED, that a planning commission be authorized to provide planning for the City of Oroville and for the North Okanogan County region contiguous to the City of Oroville;

BE IT FURTHER RESOLVED that the Commission is knows as the "Oroville Regional Planning Advisory Commission (ORPAC)";

AND FURTHER that the ORPAC in an advisory capacity, provide the Oroville City Council with those planning functions needed by the City Council from time to time as necessary fact finding support for decisions of the Council;

FURTHER, that the geographically located area contiguous to the City of Oroville which provides the economy and residences of Oroville's citizens, but, which is outside the city limits of Oroville is designated as "regional." This region lies within the Okanogan County domain and therefore the County Commissioners recognize and authorize the ORPAC to perform similar planning functions for the region around the City of Oroville;

FURTHER, that ORPAC will provide planning to and work through the Okanogan County Planning Commission to provide compatibility and coordination with County planning objectives

FURTHER, that the County Planning Commission will assign a County Planner to assist ORPAC in providing liaison, coordination and clerical services needed to accomplish objectives;

FURTHER, that ORPAC will provide the Planning that is tailored for the North County requirements and needs;

FURTHER, that the Okanogan County Commissioners will approve and authorize membership to ORPAC recommended by ORPAC annually. The City Council shall approve representatives who reside within the corporate limits or Oroville.

FURTHER, that all meetings of ORPAC will be open to the public. In particular, the membership shall be represented by at least one person from each of the following interest or activity groups:

Apple Growers Apple Packers Merchants Association Wood Products Tourism Cattlemen's Association Professional Group Civic Leaders

Senior Citizens Young People Alternate Life-Style Group Service Clubs Law Enforcement Customs A Canadian from Osoyoos

and other specialists will be invited to attend as a needed fact and information finding source;

FURTHER, that the initial activities of ORPAC will include, but will not be limited to: recommending zoning of City and County areas for residential, commercial and industrial activities; sewers and waste disposal depositories, structuring the ordinances to be positive and worded using permissive language stating what can be done, designate and develop an industrial park or two. Broad areas of community needs will be identified such as--the County Fair, Power Boat Regatta, Centennial Committee, Better Business Suggestion Box, Welcome Wagon for new business, entertainment and recreation, a year-around activity calendar, a hydro-electric program, two golf tournaments (June and August).

FURTHER, that the following be appointed by the Board of County Commissioners of Okanogan County, in agreement with the Town of Oroville, to serve as members of the Oroville Regional Planning Advisory Commission (ORPAC), as created by this Resolution:

A planning commission is authorized to provide planning for the city of Oroville and for the North Okanogan County region contiguous to the city of Oroville. (Res. 63-86, 1986).

2.66.020 Title.

The commission is known as the "Oroville Regional Planning Advisory Commission (ORPAC)." (Res. 63-86, 1986).

2.66.030 Advisory capacity.

The ORPAC, in an advisory capacity, shall provide the Oroville city council with those planning functions needed by the city council from time to time as necessary fact finding support for decisions of the council. (Res. 63-86, 1986).

2.66.040 Scope.

The geographically located area contiguous to the city of Oroville which provides the economy and residences of Oroville's citizens, but which is outside the city limits of Oroville is designated as "regional." This region lies within the county domain and therefore the county commissioners recognize and authorize the ORPAC to perform similar planning functions for the region around the city of Oroville. (Res. 63-86,

2.66.050 Cooperation with planning commission.

A. ORPAC will provide planning to and work through the county planning commission to provide compatibility and coordination with county planning objectives.

B. The county planning commission will assign a county planner to assist ORPAC in providing liaison, coordination and clerical services needed to accomplish objectives. (Res. 63-86, 1986).

2.66.060 Specific planning duty.

ORPAC will provide the planning that is tailored for the north county requirements and needs. (Res. 63-86, 1986).

2.66.070 Membership - Meetings.

A. The county commissioners will approve and authorize membership to ORPAC recommended by ORPAC annually. The city council shall approve representatives who reside within the corporate limits of Oroville.

- B. All meetings of ORPAC will be open to the public. In particular, the membership shall be represented by at least one person from each of the following interest or activity groups:
 - 1. Apple growers;
 - 2. Apple packers;
 - 3. Merchant's association;
 - 4. Wood products;
 - 5. Tourism;
 - 6. Cattlemen's association;
 - 7. Professional group;
 - 8. Civic leaders;
 - 9. Senior citizens;
 - 10. Young people;
 - 11. Alternate life-style group;
 - 12. Service clubs;
 - 13. Law enforcement;
 - 14. Customs:
 - 15. A Canadians from Osoyoos; and other specialists will be invited to attend as a needed fact and information finding source. (Res. 63-86, 1986).

2.66.080 Initial activities.

The initial activities of ORPAC will include, but will not be limited to: recommending zoning of city and county areas for residential, commercial and industrial activities; sewers and waste disposal depositories, structuring the ordinances to be positive and worded using permissive language stating what can be done, designate and develop an industrial park or two. Board areas of community needs will be identified such as the county fair, power boat regatta, centennial committee, better business suggestion box, welcome wagon for new business, entertainment and recreation, a year-round activity calendar, a hydroelectric program, two golf tournaments (June and August).
