3. A bench warrant can be issued for my arrest.
4. The court may turn over this account to a collection agency and additional fees will be assessed.

If my fine becomes delinquent, I am responsible for all additional charges including collection fees, attorney fees and court costs.

DELINQUENT ACCOUNTS

Persons, who fail to make payments as agreed in the written Time Payment Agreement, are considered delinquent and **will be** referred for follow-up action, which may include one or more of the following, depending upon case type, total balance and account history.

- Warrant of Arrest for failure to pay;
- Suspension of Driving privilege; (*includes added court fee currently \$52.00, as well as a reinstatement fee assessed by the Department of Licensing*);
- Set-up Fee to **continue** making time payments through Dynamic Collectors CPMS Program (Currently \$15 plus 1st monthly payment)
- **Monthly** Time Payment Fee to continue making time payments through Dynamic Collectors CPMS Program (\$4.75 to \$11.25 per month depending on the number of cases and account status)
- Added Collection Fees
- Interest accrues on all outstanding amounts referred to Dynamic Collectors for Collection or Time Payment arrangements at 12% per annum
