RESOLUTION TO APPROVE ORION TOWNSHIP  
FIRE DEPARTMENT ORDINANCE FEE SCHEDULE**

**WHEREAS** the Orion Township Board of Trustees adopted a Cost Recovery Ordinance at its April 5, 2021, meeting for purposes of obtaining reimbursement for certain services provided by the Township Fire Department; and

**WHEREAS** as set forth under the Cost Recovery Ordinance, there shall be an associated fee for certain services the Township Fire Department provides that are chargeable to the users of those services as enumerated under Art. III, Sec. 1 of the Ordinance; and

**WHEREAS** the fee schedule for the Township's services shall be assessed in accordance with the following schedule:

**I. Apparatus (Hourly Fees)**

- General Staff Car: (Chief Car, Utility, Inspector Car) \$70.00 per hr.
- BLS Transporting Ambulance: \$100.00 per hr.
- ALS Transporting Ambulance: \$120.00 per hr.
- Special Response Vehicle (Gator): \$75.00 per hr.
- Fire Engine: \$340.00 per hr.
- Heavy Rescue: \$400.00 per hr.
- Ladder/Aerial: \$520.00 per hr.

**II. Orion Fire Department Staffing**

- Fire Chief: \$106.53 per hr.
- Asst Chief: \$96.69 per hr.
- Fire Marshal: \$84.44 per hr.
- Fire Inspector: \$79.77 per hr.
- Captain: \$64.53 per hr.
- Lieutenant: \$60.63 per hr.
- Firefighter: \$57.08 per hr.

**III. Special Situations**

- Fire Investigation: \$50.00 per hr. per person
- Equipment Damage: Cost of repair or replacement
- Assisted-Living Facility Lift Assist: \$250.00
- Extrication: \$500.00
