Vice Chairman William Eick called the meeting to order at 4:30 p.m. followed by the Pledge to the Flag. Reverend Daniel Thurber then gave the invocation.

Clerk Lisa Stenshorn called the roll. Present in the Chambers were Legislators Allport, Draper, Eick, Fitzak, Miller and Morgan. Legislator Lynne Johnson was absent.

The Clerk presented the following Communications: The Royal Body Shop Outreach Ministries is asking to host an Easter Egg Hunt on the lawn of the Courthouse, April 9, 2022 from 1:00 p.m.-3:00 p.m. This will be open to the public. The request does include the use of power for a small speaker/microphone system and to place yard signs from March 25, 2022 through April 9, 2022. **Board Approved**

Orleans County Treasurer, Kim DeFrank has submitted a list of Inter Fund loans to Special Grant – WIA from December 21, 2021 to date as directed in Resolution No. 175-418; this will be filed in the Clerk of the Legislature Office. The Treasurer has forwarded a listing of Real Property Tax Refunds, in the amount of \$290.52, that has been reviewed and authorized by her office. Also received was one resolution from the Town of Yates: Resolution No. 35-2/22 Resolution Opposing All Covid 19 Mandates.

Legislator Allport presented a proclamation to The ARC GLOW New York declaring March 2022 as Developmental Disabilities Awareness Month. Present via zoom were CEO Martin Miskell and Board President Sherry Englert. Mr. Miskell thanked the Legislators for this Proclamation. The ARC of Genesee and Orleans merged five (5) years ago. On October 1, 2021, they merged with ARC of Livingston Wyoming. Work is now being done to smoothly streamline into one (1) large corporation. After 12 years of drastic cuts and major lack of funding, NYS is finally addressing ARC in the adult field and moving forward with the preschool side. Newly elected Board President, Sherry Englert stated that she has been a partner of over 40 years. She started as a parent of a preschool child with disabilities. He now lives in a group home and goes to a day program. As an advocate for all families and children with disabilities, she sees programs from birth to death in all types of settings. There are over 2,000 folks served in 4 counties with 1,000 staff. In the month of March, ARC is working on growing their membership to give more ears in the communities and voices to ask for support. During the pandemic, they were able to keep workers on the line working day in and day out. ARC is very appreciative to those that still came to work. Let's go forth together.

County Treasurer Kimberly DeFrank stated the report looks very good. Tax collection from the towns is coming in nicely. The Treasurer's office continues working to close out the 2021 books. The Community College fund is under the cap budget, so there will be no charge the Towns.

Vice Chairman Eick asked the Legislators if there was any open discussion as it related to the resolutions, no discussion was raised.

Vice Chairman Eick then asked the public for any open discussion as it related to the resolutions.

John Kast, Orleans County Farm Bureau. Mr. Kast stated that on January 28, 2022 the threemember wage board voted, 2-1 to recommend lowering the Farm Workers overtime threshold to 40 hours over the next ten years. This decrease would happen incrementally - 4 hours every other year. 2024 - 56, 2026 - 52. And would get to 40 hours in 2032. The DOL has 45 days to develop a report and submit to the Governor. There is a two-week public comment that follows the report submission and then the Governor has final decision. The decision to lower the Overtime threshold will dramatically increase a farms operating cost, with no way to adjust or recoup those costs. Farms do not have the ability to set prices on our commodities. We are at the mercy of our buyers and futures markets. Unlike many other businesses that can raise prices or make other adjustments like adding self-checkout systems or kiosks for ordering we must absorb the extra cost which is unsustainable. Orleans County farms grow a lot of labor-intensive crops like Apples, Cherries, Cabbage and Squash. All of which do not have efficient mechanical harvesting systems available to utilize. So, we rely on manual labor to get the job done in an efficient and timely manner. Farming is also a very weather dependent business. We often have a very small window to plant, maintain and harvest our crops. For example, if we get one or two days of rain at peak apple harvest and are not able pick before the apples become overripe, we can lose Thousands of dollars of potential income because of the delay. Therefore, when the rain stops, we must put in long days to get the crop harvested as soon as possible. Orleans County farms relied on over 1,500 seasonal workers last year to harvest crops. Most of them are here on Visas through the federal H2A program and are here for a very limited time period. Their goal is to work as much as possible while they are here to take as much money back home to their families. Many of them spend a significant amount of money in the County while they are here. If the Threshold drops, many farmers are looking at two possible options to survive: 1. Try to limit hours worked to under the threshold and hope that there is enough time to harvest crops. 2. Stop growing labor intensive crops and grow more processing and grain crops which can be done with less labor. Either option means less hours, less opportunity and less money for the seasonal workers. There are States all around us that do not have overtime rules for agriculture and many of our workers have told us that if they will earn less money here and cannot work as much as they are able to, they will go elsewhere where they can. Our workers are like family to many of us. Often workers have been coming up for many years and in some cases multiple generations. We want them to enjoy working for us while being able to provide a good living wage for their families. Something often overlooked: for workers in the H2A program not only are farms required to pay a federal mandated wage well above minimum wage for the area (\$15.66 for 2022), but farms also cover their Visa costs, all travel costs here and back home, provide transportation and housing during their time here. Our housing facilities are inspected by the Local Health Department and are maintained under strict requirements from the New York State Department of Labor and Department of Health. Which is more than what most apartments and condos are required to do. All of which provides additional benefits to our workers and adds additional costs to our Farms. Orleans County Farm Bureau is asking that you stand with your county farms and ask Governor Hochul to keep the Threshold at 60 hours for the long-term viability of Agriculture in Orleans County and NY State.

Hearing no other public comment on resolutions, Vice Chairman Eick began with the presentation of resolutions.

WHEREAS, since its inception, Western OTB has generated over \$250 million in operating and surcharge revenues to the taxpayers of those participating municipalities; and

WHEREAS, throughout its long history of serving the 15 counties and two cities that comprise the corporation, the Board of Directors of WROTB has been comprised of one representative from each of the 17 municipalities; and

WHEREAS, in 1973, the Orleans County Board of Supervisors passed by resolution legislation that authorized and empowered Orleans County to participate in the WROTB that had recently been created by the state and signed by then Governor Nelson Rockefeller; and

WHEREAS, the 1973 legislation passed by the Orleans County Board of Supervisors was passed with the stipulation that it was "subject to permissive referendum and shall become effective in accordance with Section 24 of the Municipal Home Rule Law of the State of New York"; and

Kennedy's proposal calls for revising the current fair and equitable representation of the Board of Directors to three members to represent the counties of Monroe, Wyoming, and Orleans; a single member to represent the counties of Chautauqua, Cayuga, Genesee, Livingston, Schuyler, and Seneca; four members to represent Erie County; one member to represent Niagara County, a lone member to represent the counties of Oswego, Cattaraugus, and Wayne; one member to represent the City of Buffalo, one member to represent the City of Rochester, one member appointed by the governor, one member appointed by the temporary president of the senate, and one member appointed by the speaker of the assembly; and

WHEREAS, under Senator Kennedy's proposal, Steuben County is not provided any representation on the WROTB Board of Director even though they have been a member of the WROTB since 1973; and

WHEREAS, Sen. Kennedy's bill states that its intent is to "provide more equal representation of the people of the area who benefit from proceeds from said corporation"; and

WHEREAS, this legislation will in fact have the opposite effect of the stated intention in the bill, as it will decimate the balanced representation formula determined previously by both the state legislature and governor as equitable and impartial, with a clear and explicit intent of providing each municipality that comprises the corporation an equal voice in WROTB matters; and

WHEREAS, the performance and accomplishments of the current WROTB Board and leadership cannot be discounted when considering this drastic and overreaching legislation, including, but not limited to: the acquisition of an 84-room hotel on the grounds of Batavia Downs that has drawn rave reviews, countless fundraising events for charitable organizations that have benefitted thousands of families across western New York, including Make-A-Wish, the Batavia Police Department K-9 Unit, the Genesee County K-9 Unit, GLOW YMCA, Food Bank of Western New York, and the Breast Cancer Coalition of Rochester; and

WHEREAS, in 2021, Batavia Downs once again shattered attendance and wager records, with more than 625,000 attendees wagering nearly \$700 million this past year alone, leading to record earnings distributions for the 17 municipalities that have come to rely on their WROTB distributions to balance their local budgets while reducing the property tax burden for businesses and homeowners; and

WHEREAS, the current WROTB Board and leadership have successfully led the corporation through in incredibly difficult period in history, the Covid-19 pandemic, that has ravaged similar entities across the state and the country; and

WHEREAS, WROTB currently has 385 full- and part-time employees with a payroll of \$12.5 million; individuals and families from every corner of our region, and all whom could be negatively impacted by this drastic proposal; now be it

RESOLVED, Orleans County Legislatures does vehemently oppose Senate Bill S7855, as it will cause irreparable harm to Orleans County, its interests in WROTB, the economic interests of Orleans County, and the taxpayers of this county; and be it further

RESOLVED, that the Orleans County Legislature does hereby call upon members of the New York State Senate to reject S7855; and be it further

RESOLVED, that a copy of this resolution be sent to Governor, Senate and Assembly.

26. The County of Orleans will execute no warranties concerning the parcel or title thereto and will not deliver or be responsible for abstracts, title insurance, title searches, surveys, maps or other documents concerning a parcel whatsoever.

27. Conveyance shall be by quitclaim deed only, containing a description of the property as it appeared on the tax roll for the year upon which the County acquired title or as corrected up to date of deed. The deed will be recorded by the County upon payment in full of the accepted purchase price, buyer's premium, and closing fees/costs. POSSESSION OF PROPERTY IS FORBIDDEN UNTIL THE DEED IS RECORDED WITH THE ORLEANS COUNTY CLERK CONVEYING TITLE TO THE PURCHASER. TITLE VESTS AT THE RECORDING OF THE DEED. It is agreed between the County and the purchaser that delivery and acceptance of the deed occurs upon recording the deed.

28. A quitclaim deed issued as a result of the auction shall contain the following provisions: (a) "Nothing contained in any description herein is intended to convey more than the assessed owner owned at the time of the levy of the tax, the non-payment of which resulted in the tax sale. There is no representation as to the extent of the acreage conveyed herein;" (b) Orleans County shall in no event be or become liable for any defect in the title so conveyed for any cause whatsoever, or for any encroachments or disputed boundaries; and that no claim or demand of any nature shall ever be made against said Orleans County arising from such sale or conveyance or any proceedings leading thereto.

29. Evictions, if necessary, are solely the responsibility of the successful purchaser after closing and recording of the deed. PLEASE NOTE: All bidders are advised that the properties are sold subject to the rights of tenants or persons otherwise occupying the properties, if any. Responsibility to evict any tenants or take similar action concerning occupancy of the premises is the sole responsibility of the bidder.
