Legislature Meeting March 23, 2022

Chairman Lynne Johnson called the meeting to order at 4:30 followed by the Pledge to the Flag. Reverend Brandon Carmichael of the Victory Baptist Church in Albion gave the invocation.

Clerk Lisa Stenshorn called the roll. Present in the Chambers were Legislators Allport, Eick, Fitzak, Morgan and Johnson. Legislators Draper and Morgan were absent.

The Clerk presented the following Communication: Orleans County Treasurer Kimberly DeFrank has filled the 2021 year end reports for the following Capital Projects: County Office Building Addition & Renovations, Infrastructure Projects and Lake Ontario REDI Projects.

Orleans County Treasurer, Kimberly DeFrank stated that the finances are doing well. The report handed out show the tax collection coming in from the towns. Everything is running smoothly.

Chairman Johnson asked the Legislators for any open discussion as it related to the resolutions, hearing none Chairman Lynne Johnson offered the 'Orleans County State of the County' address:

Good afternoon and thank you for joining us today.

In the past I appeared before you and we were at the mercy of COVID-19. We were bending and twisting and trying to conform our lives to this deadly, destructive illness. But today look at us, look at us. Through creativity, sacrifice, discipline, and vaccinations we are fighting back and overcoming.

We have a long way to go my friends; we still aren't fully back, but we are getting there, and we are united.

Some days, it feels like we just started, and other days, well other days are other days.

I want to publicly thank the incredible 400 plus County employees for their dedication to each other and the people of this county. You have worked tirelessly during a lockdown, and then as we began to open you volunteered at vaccine clinics to get our people vaccinated. And thank you to our county residents for being active, engaged citizens, a part of this amazing County. Thank you for joining our effort to lead us through this pandemic.

President Harry Truman once said, "America was built on courage, on imagination and unbeatable determination, to do the job at hand". I'm here to tell you that we are here to do the job at hand and united, we will do the job at hand. Because of our unity we will move forward.

There are so many notable facts worth mentioning that made this last year great for Orleans County and gives us the example of strength and creativity to prepare for next year. We have presented a budget under the 2% state mandated tax cap. We made hard financial decisions when faced difficult financial times, but we made smart choices with federal dollars that not only saved the County money, but also provided essential services for the public when and where they

needed it most. Our efforts with broadband have been successful. RTO will service 100% of the residents in Orleans County.

I want to be clear, this is how government is supposed to work which means good government. We have worked every day for you, and I mean that. During this pandemic, many of our Orleans County neighbors struggled mightily to survive. We have provided a helping hand to the communities around us and our many partner agencies, we demonstrated grace under pressure. We helped our neighbors get through this, it is part of our being, and our residents remember. We have been a true force for good.

I am proud and inspired by the way our county has risen to this challenge, with flexibility, resilience, courage, creativity, and a caring heart. I thank our employees for their enormous contributions. Let's keep working together across all departments, across all towns and villages. Let's make this year our finest hour. I am convinced we will get through this with our self-confidence and our energy. It is literally in our hands.

Orleans County started vaccinating on January 5^{th} , 2021. We were learning and teaching each other how to vaccinate for COVID-19. From that moment it has been nonstop.

There are many of our workers and citizens out there, hands doing the jobs and carrying the load for others, with quiet voices and steady hands. They don't get a lot of attention, nor do they seek it, but they deserve our thanks.

I thank the Orleans County Health Department under the leadership of Paul Pettit, for their tireless work. The men and women of the Health Department lead the fight in educating us, testing us, and continue to vaccinate us, to all of you I say thank you.

We have worked regularly with the County's school superintendents to help them navigate the reopening process in assisting their teachers, faculty and staff to be vaccinated because we recognize that the schools need to be open, and the children of this County need to be in the classroom

This pandemic also shined a light on the dedicated and committed work of our Orleans County Sheriff's Department under the leadership of Sheriff Chris Bourke, vigilant in efforts to protect the county and keeping watch over us. The County's Police Reform and Reimagining Task Force made up of law enforcement, an attorney, and key stake holders seeking to implement positive reform issued an extensive report after five months of intensive collaboration and that report was approved unanimously by the Legislature.

As we have been, since day one of this crisis, County government has an all-hands-on-deck approach to help Orleans through this unprecedented pandemic. Through the County's Office for the Aging, under the leadership of Melissa Blanar, we have sought all available resources to help the County's senior population navigate the vaccine appointment process.

As I appear here before you today, know that over 100 of our brothers and sisters are gone. Lost to COVID-19. We want to honor those men and women as much as we can: the moms, the dads, the sisters, and brothers. No life lost is ever a statistic, they are people, they loved and we loved them. They laughed and cried and walked among us. Perhaps the greatest way to honor those we have lost is to show love to our neighbors, the people with whom we share these streets and be the best we can be.

Friends, we live in a time of extraordinary change, how we work, where we work, how we educate our children, and how we take care of ourselves. In the past our goal has been growing the economy, making sound financial decisions, and attracting new businesses. But we have also been creating a community that works for everyone – because that is what good government is supposed to do. In the COVID world we now live in, we must continue to focus on growing the economy, and as we know the workers, start-ups and small businesses are going to play a big role, support them, buy local because the spirit of innovation and creativity is here, it was always here. Now it's our job to help this spirit to continue.

We appointed Holli Nenni, who has a long career in that field, to take charge of the Department of Social Services – the County's largest department that serves many. As you know, county governance is all about us, so if you think you have fresh ideas and skills that would further enhance services at the County, we encourage you to visit the County's website. We want you to be part of this spirit.

In a year and a half when it feels so much has been torn down, I want you to know we are building up. We submitted a Capital Budget that contained over \$5 million dollars in new appropriations for capital projects. When it comes to infrastructure in Orleans – we are building in a way that has never been seen in recent memory. I thank Department of Public Works Commissioner John Papponetti for his leadership in sharing services for rebuilding and construction.

In a post-war world, President Truman said: "At no time in our history has unity among our people been so vital as it is at the present time. Unity of purpose, unity of effort, and unity of spirit are essential to accomplish the task before us."

Ladies and gentlemen, I am here to tell you today that the State of our County, Orleans County, is strong and getting stronger with the unity of spirit and our purpose. Yes, we have more work to do, but we are here to do the job at hand, you are here to do the job at hand and together, united – we will do the job at hand. Because WE are Orleans County, and we are united to move forward.

I am asking you to continue to travel with me on this journey – help us to continue to rebuild our County. Orleans has been through big changes before us; wars, depression, hurricanes, floods, and now a pandemic. During every difficult part in our history, there have been those who told us we should fear these crises, we should do less and avoid change, but I am here to tell you something you already know, change is constant, and change is inevitable. We will evaluate the old to keep the good and rather than fighting change, we must embrace it and shape it and own it – because that is what Orleans County residents do, that is what New Yorkers do and that is what Americans do. When we make change work for us, we always move forward, and, in the end, we always emerge stronger, wiser, and better than before. We are not tired, and we are far done. We are reaching and striving always to do the job at hand. Thank you.

Chairman Johnson then asked the Public for any open discussion as it related to the resolutions. There being none offered, Chairman Johnson ask Legislator Allport to present the proclamation declaring April 2, 2022 as World Autism Awareness Day and April 2022 as World Autism Month. Jessica James, an Autism Speaks advocate, was very excited to receive the proclamation. Miss James stated "Words can't describe how happy I am to be here. Thank you

very much."

WHEREAS, the Owner has submitted, or will submit to the assessor of the Town of Gaines an RP – 487 Application for Tax Exemption of Solar or Wind Energy Systems or Farm Waste Energy Systems, demonstrating the Project's eligibility for a real property tax exemption pursuant to RPTL Section 487; and

WHEREAS, the Parties intend that, during the term of this Agreement, the Project will be placed on an exempt portion of the assessment roll and the Owner will not be assessed for any statutory real property taxes for which it might otherwise be subject to under New York law with respect to the Project; now, therefore be it
