Legislature Meeting July 28, 2021

Chairman Lynne Johnson called the meeting to order at 4:30 p.m. Veteran Legislator Kenneth DeRoller led us in the Pledge to the Flag followed by an Invocation.

Clerk Lisa Stenshorn called the roll. All Legislators were present in the Chambers.

The Clerk presented the following Communications: Treasurer Kimberly DeFrank has filed the list of Inter Fund loans to Special Grant-WIA that were issued from June 4, 2021 to date as directed in Resolution No. 175-418 in the Clerk of the Legislature Office. The Clerk has also received the year-end adjustments to fiscal year 2020.

Treasurer Kimberly DeFrank stated the American Rescue Funds are indicated under Federal Aid, these funds came in during June. There is a transfer to other funds for \$1.5 million from the road fund levy that was paid out to the towns for moving and plowing. Revenue is coming in nicely and our cash looks to be in great shape.

Legislator Draper presented Orleans County Probation Director, Luci Welch with Katie Vick and Heather Jackson of the Probation Department with a Proclamation declaring the week of July 18-24, 2021 as Pre-Trial, Probation, and Parole Supervision Week.

Legislator Draper presented a Special Recognition to Probation Director Luci Welch for being elected as the 2021 President of the New York State Council of Probation Administrators (COPA).

Chairman Johnson asked for open discussion as it relates to the resolutions presented.

Legislator DeRoller spoke about the legalization of marijuana. The towns have till December 31, 2021 to opt out of the sale of recreational on site cannabis consumptions bars. The Town of Ridgeway has done this. Most municipalities in the state are opting out. Alexandria Bay and Cape Vincent are opting out until there is more information on the rules. There is no information available from the state. At the September meeting of the Association of Municipalies in Orleans County, there will be discussion about this. Attorney Bogan stated the Town of Ridgeway has a local law set for their August meeting to opt out. Towns can always opt back in, but if you don't opt out now, they by law cannot opt out next year. Until the State issues regulations it is a prudent approach to opt out.

Legislator DeRoller then spoke about the housing study being completed by LaBella Associates. Mr. DeRoller stated that he would like to bring them to a conference session next month to present an overview of the study presenting the over gaps and positives. Planning Director Jim Bensley stated the consultant was good about integrating text and graphics to sum it up in a short amount of time.

Chairman Johnson recognized the following area elected officials attending today's meeting. John Fitzak Legislator Elect with his term to begin on January 1 2022, Niagara County Legislator David Godfrey and Gaines Judge Bruce Schmidt.

Niagara County Legislator David Godfrey stated that Resolution No. 352-721 internet services for Orleans County. On January 11, 2012 by resolution Orleans County and Niagara County created the Niagara Orleans Regional Alliance (NORA). Part of that process was to look at 911 towers for mandated by the FCC to upgrade. In December of 2012 broadband was brought into the subject. NORA hired a consultant to drive every road and assess vertical access across both of the counties. We went to Albany for funding, but were blocked due to merger of Charter and Time Warner. After that Mr. Godfrey and Chairman Johnson went to Washington DC to testify before the Public Service Commission against the merger and to campaign that broadband/internet service should be nothing different than telephone service. It should be a public service. Moving forward, the USDA came up with funding, we have applied for these funds. There are also pandemic rescue funds available in both counties. We could not have found a better way to bring a critical service to our people than to use these funds to bring our communities into the 21st century. It has been a long journey. The Chairman and I actually drove every road to make sure the numbers were correct. This was a lot of work over many years. I would like to congratulate this legislature for all the work they have done and their commitment. Next week Niagara County Legislature will also be passing a resolution for bringing broadband into their county. Legislator DeRoller added that we are primed to get access, reliability and affordability into this process. To get competition into the marketplace.

Hearing no other public comment on resolutions, Chairman Johnson began with the presentation of resolutions.

WHEREAS, the Owner has submitted, or will submit to the assessor of the Town of Barre an RP-487 Application for Tax Exemption of Solar or Wind Energy Systems or Farm Waste Energy Systems, demonstrating the Project's eligibility for a real property tax exemption pursuant to RPTL Section 487; and

WHEREAS, the Parties intend that, during the term of this Agreement, the Project will be placed on an exempt portion of the assessment roll and the Owner will not be assessed for any statutory real property taxes for which it might otherwise be subject to under New York law with respect to the Project; now, therefore be it

WHEREAS, Central Orleans Volunteer Ambulance (COVA) has a new alternate representative for the EMS Board; now be it

RESOLVED, that this Legislature approve removing Chuck Prentice and adding Jonathon Miller as the Central Orleans Volunteer Ambulance alternate representative.

Chairman Lynne Johnson stated that according to the FCC definition, most of Orleans County has high-speed access to the internet. Although the residents continually report that service is slow and unreliable. And with only one provider serving much of the county, customers have little leverage to demand better service. Today marks the end of an ambitious and long sought-after quest, and the beginning of a new era for Orleans County-high-speed, reliable and affordable internet for every home and every business across out county. Our ability to diversify our economic base is dependent on modern infrastructure, and that includes broadband. We can say, 'Come and work here.' But, if we don't have a modern amenities, modern infrastructure, that sales pitch falls flat. High-speed internet breaks down those barriers of distance and time, allowing resident of rural areas to participate in economic and civic life far beyond their geographic region. Whether it is working from home, or finding & training for a new job, telehealth or our farmers competing in the global market. And let us not forget our children having to complete required online courses; ultimately it is the availability of high-speed internet that will benefit the entire county in ways too numerous to mention. It is essential that we act to finally close the digital divide that has kept so many of our rural communities from reaching their full potential. The following resolution was adopted.

AWARDING BID FOR WIRELESS INTERNET SERVICES FOR ENTIRE COUNTY OF ORLEANS FOR THE EMERGENCY MANAGEMENT OFFICE

WHEREAS, the Orleans County Department of Emergency Management Office sought bids for expanding access to mobile emergency services such as E-911 and E-911 Text, and

WHEREAS, the Orleans County Legislature is committed to insure access coverage to every address unserved in Orleans County with access to wireless internet services, and

WHEREAS, the Orleans County Legislature is desirous for our underserved residents and businesses of Orleans County to have a choice for their internet service with a Wireless Internet Services, and

WHEREAS, the leveraging of funds from the American Rescue Plan Act allows Orleans County Legislature to move forward in obtaining broadband for our unserved residents and businesses as well as our underserved residents and businesses, now be it

RESOLVED, that the Orleans County bid for Wireless Internet Services be awarded to RTO Wireless, LLC, 30 Lowell Road, Wellesley, MA 02481 at a cost of \$3,608,435.00; and be it

FURTHER RESOLVED, that the Chairman is authorized to execute said agreement to be effective as soon as the County gives notice to proceed and is subject to review and approval of the County Attorney and Chief Administrative Officer.

CAO Welch stated this enhanced Federal Medical Assistance is from the Affordable Care Act providing high level of medical services to their low income residents. There are also additional funding that has been compounded even through the COVID event. The last time it was reconciled was March of 2016. We asked the NYS Division of budget how much money was available to use. They have no record of owing us money. We then asked the Department of Health and they do know they owe us money from April 2016 for 4 years through March of 2020. They owe us \$1,600,000.00. It is difficult to get one state department to speak to another. This resolution asks then to release the funds. The following resolution was adopted.

RESOLUTION NO. 353-721

RESOLUTION CALLING ON THE GOVERNOR TO COMPLETE AFFORDABLE CARE ACT ENHANCED FEDERAL MEDICAID ASSISTANCE PERCENTAGE RECONCILIATIONS THAT ARE YEARS OVERDUE AND IMMEDIATELY RELEASE THE FEDERAL FUNDS OWED TO COUNTIES AND NEW YORK CITY

WHEREAS, the funding to support the Medicaid program is provided by a combination of federal, state and local resources; and

WHEREAS, the state requires the counties and New York City to contribute \$7.6 billion annually to pay for the federal and state defined and controlled program; and

WHEREAS, the locally required share of Medicaid funding paid in New York is the highest of any state in the country; and

WHEREAS, this large local funding share for Medicaid and other state programs is a major contributor to New York's high local tax burden compared to other states; and

WHEREAS, under the Affordable Care Act the federal government provided an enhanced Medicaid matching share (eFMAP), which has saved New York state billions of dollars; and

WHEREAS, the state is required under federal law to share these savings with counties and New York City based on the proportionate share localities pay of the nonfederal match; and

WHEREAS, the state has utilized a methodology that provides 80 percent of these estimated federal savings to counties in the year the costs accrue; and

WHEREAS, the balance of savings owed to counties is supposed to be reconciled annually to ensure the withheld savings are transferred to county budgets and local taxpayers, as well as meeting the intent of federal law; and

WHEREAS, the last completed reconciliation was for state fiscal year 2015-16; and

WHEREAS, this leaves reconciliations four years behind the normal schedule, with more than \$800 million in federal funds being withheld from counties and New York City, by NYSAC estimates; and

WHEREAS, by not providing these federal funds it requires counties and New York City to reserve funds locally to make up for the loss, meaning local taxes have been kept higher than they need to be over multiple years, or local services had to be scaled back or eliminated; and

WHEREAS, in the years leading up to the last completed eFMAP reconciliation, counties were provided an estimate of their coming year Medicaid costs by September, in time to incorporate the savings in their budgets, which ceased when regular reconciliations ended.

NOW, THEREFORE, BE IT RESOLVED, the New York State Association of Counties (NYSAC) urges the Governor to complete these unfinished reconciliations as soon as possible and to provide counties and New York City a full accounting of the federal funds owed, and to take immediate steps to release the funds to localities; and

BE IT FURTHER RESOLVED, the state should also renew its practice of providing timely notice to counties of coming year Medicaid costs so we can appropriately budget those savings for local taxpayers and to preserve highly desired quality of life services provided locally; and

BE IT FURTHER RESOLVED, that copies of this resolution be sent to the counties of New York State encouraging member counties to enact similar resolutions; and

BE IT FURTHER RESOLVED that NYSAC shall forward copies of this resolution to Governor Andrew M. Cuomo, the New York State Legislature, and all others deemed necessary and proper.
