COB North Chiller Replacement Project Update.	<ul> <li>Due to a delay in obtaining necessary parts, there has been a change in the ship date of the new chiller unit. The new projected ship date is July 26, 2022. Due to this delay, we will need to rent a temporary chiller to maintain a comfortable work environment during the timeframe of mid-May to mid-August. Trane has provided an estimate to rent, install and remove a temporary chiller unit for a three month duration. Trane has also offered a 25% discount due to the inconvenience of this delay. The non-discounted price is as follows:</li> <li>\$21,000 - one-time fee for mobilization, electrical/piping infrastructure modifications, and installation/decommission of rental equipment</li> <li>\$13,200 - monthly fee for the rental equipment (trailer, chiller, pump, hose, cable)</li> <li>\$4,000 - round-trip freight charges</li> </ul>	Committee Agreed to move forward with the temporary chiller unit. Yates Carlton Townline Road Emergency Culvert Replacement Project Update.	The survey and hydraulic evaluation has been completed. Various size and shaped culverts were evaluated. Based on lead time for fabrication and availability of materials, it has been decided to replace the failed culvert with a dual 60" dia. SICPP culvert. The County DPW has this pipe in inventory which will help with speed of construction and getting the road open to traffic. Commissioner is still seeking the assistance from a local contractor to complete certain aspects of this project.	Committee Agreed with the Commissioner's recommendation.
