Honorable Members of the Orleans County Legislature:

Please accept the filing of the following document as the 2021 Orleans County Tentative Budget representing the 2021 operating and capital program. This year's \$73 million budget recommendation is highly influenced by the impact of the COVID-19 pandemic as well as New York State's fiscal challenges for the 2020-2021 budget year.

The financial challenges we are experiencing include our businesses being restricted in their operations due to the changing COVID-19 operating guidelines that must be followed. This has affected our residents purchasing from local businesses which has changed the historical patterns of sales tax revenue for 2020. Therefore forecasting 2021 sales tax revenues is challenging at best. As of the date of this budget message, New York State has not implemented the revenue reductions to local municipalities' aid for the current budget year which started April 1, 2020. These were components of the State's current budget plan that was put into law. Therefore, it is challenging to predict what reductions to local municipalities' aid will be budgeted by New York State in next year's State budget.

On March 31, 2020 the stock market reached one of its lowest values in a year. Unfortunately, this is also the date when the New York State Comptroller takes the valuation of the retirement fund to set retirement rates for 2021. This loss in value of the retirement fund has created nearly a 20% increase in the retirement expense in 2021. In 2020, we have also seen an increase in pharmaceutical costs in our health plan which has created a 19% increase in the health insurance premiums for 2021. We are in the middle of a two year annual sales tax diversion of \$190,274 for

Fiscally Distressed Health Facilities. Of course we have had to plan for continued use of PPE for our employees as well as for heightened cleaning and disinfecting of our facilities in 2021.

Given these challenges for the 2021 budget we are striving to maintain our consistent and stable approach to investment in the county infrastructure, the organization and ongoing fiscal stability.

The goals for this year's budget were introduced to the department heads back in August and reinforced throughout the process by the administration and the legislature. These goals provide the framework in which spending decisions are evaluated and eventually implemented.

- Maintain core county services and programs in the most cost effective manner possible
- Comply with the New York State property tax cap
- Provide funding for priorities projects and programs while avoiding fiscal stress
- Protect operational and fiscal stability
- Use realistic estimates for variable revenue
- Support capital investment goals
- Provide a balance budget
- Address changes in the law and resulting unfunded mandates

Plan Overview

The plan contains a levy increase of \$299,497 or 1.66%. The 2021 Tentative Budget proposes expenditures of \$73,262,025 or a \$1,550,387 (2.16%) increase and \$51,478,807 in revenues or a \$141,868 or (0.27%) increase. The budget accomplishes several critical programmatic and fiscal goals, remaining New York State Property Tax Cap compliant and sets a tax rate of \$9.98, an 11 cent per thousand increase (or 1.114%). The increase in the levy (1.66%) is compliant with the New York State property tax cap.

The 2021 budget continues to maximize funding opportunities at the State and Federal levels to advance our infrastructure Capital Plan for bridges and culverts. This plan reflects a continuation of the county's efforts to enhance infrastructure, grow tourism and expand future planning.

Local Government Support

The Tentative Budget also continues to support other Orleans County municipalities. The 2021 budgeted support for villages and towns comes in just over \$4.0 million adding approximately \$2.22 per thousand to the county property tax rate, this is up from \$3.8 million. This calculation includes the prosecution of Vehicle and Traffic offenses, AIM Related payments and the County's support for community college chargebacks in the amount of \$2,050,000, which is capped for the first time in 2021. The 2021 Tentative Budget continues sales tax support at the current level of \$1,366,671.

Position Schedule

The Tentative Budget funds 421 positions both full and part time across numerous programs and services. This is a reduction of 8 full time positions and 12 part time positions from 2020.

Solid Waste Pick Up

The fee for solid waste and recycling service will be \$216, which is a 2% increase over 2020. The current fee will continue to support the e-waste collection efforts for county residents at three sites across Orleans County. The program remains very popular, with high demand for the disposal of CRT monitors and televisions. The county is also planning to continue to offer the Household Hazardous Waste pick up annually.

Conclusion

Finally, a thank you to the county department heads and their employees for their assistance, professionalism and pro-activeness while preparing this recommended budget. Once again, these individuals represent some of the best that public service has to offer.

Thanks also goes to the Orleans County Legislature, an exceptional group with which to work.

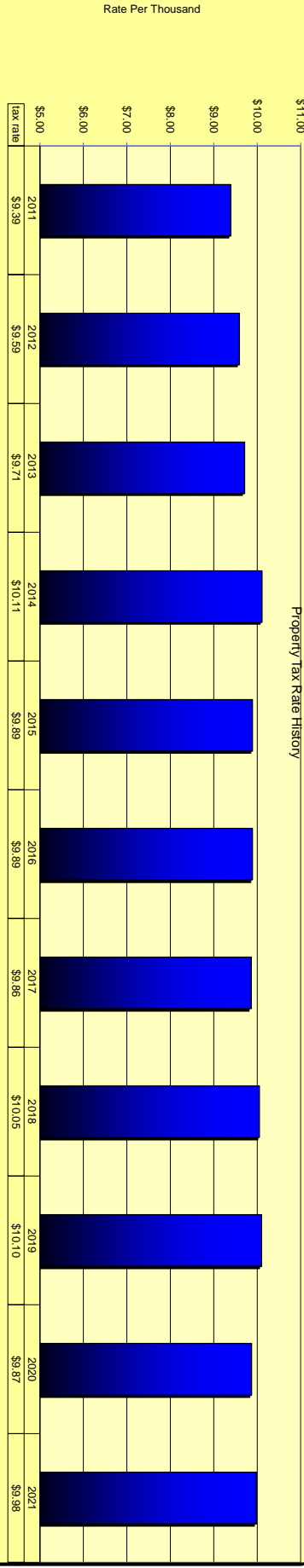

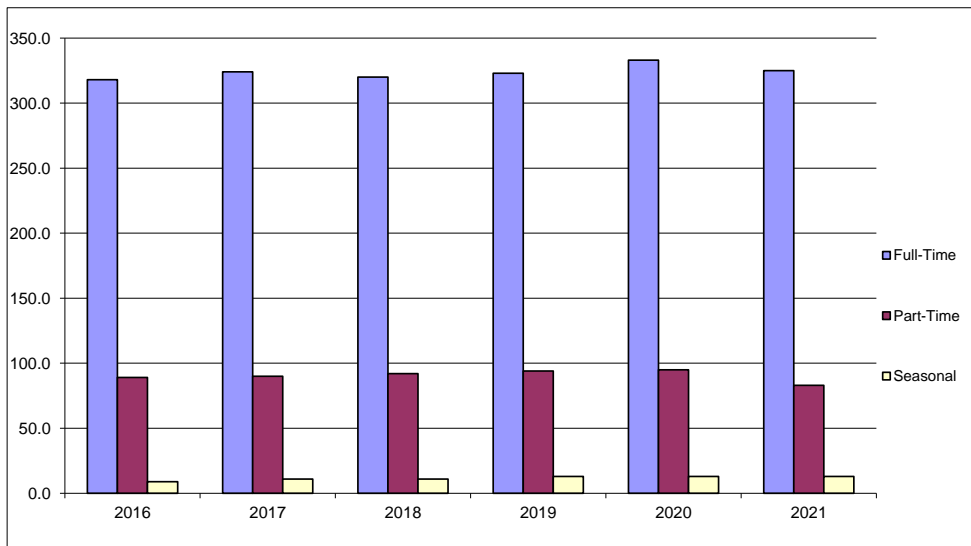
