The member of the Collaborative group along with administration are James White-Marine Deputy Sheriff, Margarita Aldaco-Program Administrator of Pathstone Violence Program, Eddie English-Pastor of the Lords House, Terllis Pore- Pastor of Mt. Zion Missionary Baptist Church, NYS Corrections Officer and NYSDOCCS certified instructor for Fire Arms, Defensive Tactics and Chemical Agents, and Thaddeus Nauden- Deacon at the Royal Church of God in Christ, Senior Citizen and Veteran of the United States Air Force. This team went over the entire Orleans County Sheriff Office mission statement and policies. A lot of good collaboration was had. There were public hearings via zoom,

in which we received different yet valuable attributes to add to the Plan. Orleans County defiantly filled Executive Order 203 to its full assignment that was given.
