Local Law No. 4 of the Year 2011

SECTION 1. LEGISLATIVE INTENT.

It is hereby determined that the costs of New York State imposed mandates and of the Orleans County Nursing Home known as the Villages of Orleans have become significant burdens upon the County of Orleans and that the real property tax payers of Orleans County should be informed of the amounts of local real property tax dollars that are required to cover these costs.

SECTION 2. INFORMATION.

In addition to the information set forth in section 922 of the Real Property Tax Law of the State of New York, the real property tax statements shall separately list the amounts attributed to New York State Imposed Mandates, the County Nursing Home, and General County Services in the County portion of the real property tax statement.

SECTION 3. EFFECTIVE DATE.

This Local Law shall take effect immediately upon filing in the office of the Secretary of State.
