<u>Jeremy Spencer</u>- Furtaw Field has been on everyone's mind for the past few week. The Park is for everyone in the community and we must look at what is best for the community and not just the individuals. We need to do this as a community if we are going to move forward. The developers didn't even get to present their plan. We will all come together and bring people to the downtown.

<u>William Palmer</u>- If we really want to improve this township, we need to consider the developers. We have opportunity zones designated by the state downtown that we can get funding for. I hope that we will listen to proposals in the future and be more cooperative

<u>Steven Wusterbarth</u>- Agrees with Mr. Spencer and Mr. Palmer. The way we will get improvement is if we start downtown. Let's talk about the pros and cons together and decide

Ann Richards- In 2017an RFP was issued to solicit a vendor to look at public development options for three of our parks, Furtaw Field was included, the cost was approximately \$17,000. Around the 2019 time frame the former Superintendent and I am not sure which other board members looked at placing a municipal consolidated building on Furtaw Field, costs were incurred to do so - the public was upset. In December 2020 after the newly elected board took office, we received an LOI for Furtaw Field that we were told was derived from conversations a developer had with the former Superintendent and I am not sure what board members or staff for over a year. Perhaps if we would have had open dialogue in the beginning about possible mix use options for Furtaw Field we would not now be facing so much confusion and community unrest. Moving forward this will not happen again.
