Public Comment -

Clayton Jolly – According to the newspaper we are losing 48% of the water we purchased, and I wondered why we aren't spending more time trying to find out where that water is going?

Lary Holland – Recommended putting flow meters on sectioned quadrants to track leaks, alerted the board that his meter had failed during a fire and water was lost, and played a song for the board that he made using artificial intelligence supporting the New Oscoda Underground on Facebook that is brining in music and more to Oscoda.

Cathy Wusterbarth - Michigan Department of Health and Human Services exposure assessment. I want to remind people that just because you don't live in an area that may have been affected by the contamination we are all being affected by contamination through consumer products, through any sort of stain resistant clothing that we wear, I mean it's being used in thousands and thousands and thousands of products, it's not just from firefighting foam from the base so this is your opportunity to see what is in your body because of all of those other things. Kelly Brown – Question on KRATOS and who authorized it, recommended a higher level of oversight on payables, you have to work together and treat each other equally, I think we need a forensic audit for payables, and I just feel that they're starting to show a level of disparate treatment towards the female members.

I looked it up the water systems are not hermetically sealed, they are going to leak it's the way it is you're putting pipes under the ground and

you cannot stop it the ground moves more in some cases than in others water flows around underneath the ground and moves things around and those pipes will not last forever it's the nature of everything that is man-made it breaks down.
