GROUP SWIM LESSONS

Cost: \$40/child/session

Descriptions: Water Babies (Wat Bab) (6-36 months WITH parent/guardian)

Beginner (Beg) – Introduction to water skills (3 years & up)

Intermediate (Int) – Fundamental aquatic skills (5 years & up)

Maximum of 1 instructor to 6 participants.

Sessions will meet Monday-Thursday; Friday reserved for weather make-up.

Registration deadline is one week prior to session start, if not already full.

\$5 late fee will be applied to any registration accepted after deadline.

- All lessons held outdoors at Winter Water Park (705 Parker Drive).
- Must be minimum age listed prior to first day.
- Parent/guardian is to stay onsite during lesson.
- All participants who are not potty-trained **MUST** wear a swim diaper. In the event a child has an accident and not wearing a swim diaper, parent will be charged a \$50 cleaning fee.
- Payment is due in full at time of registration.
