This is the rental agreement for golf cart storage space at Owensville Golf Course. Completed forms and fees must be submitted by April 1. Failure to submit fees and forms by this deadline shall constitute non-renewal of the lease of space, and the space will be made available to other interested people. If you have any questions, please contact the clubhouse.

Rules and Regulations for use of Private Golf Carts at Owensville Golf Course:

1. The City of Owensville, Owensville Golf Course, and its officials (elected and/or appointed), employees, agents and/or representatives are not responsible or liable for losses incurred by cart owners. **You are solely responsible for providing your own sufficient liability and casualty insurance for your cart, and that you are required to obtain and maintain property sufficient liability and casualty insurance for your cart while it is stored and used at the Owensville Golf Course.** Failure to maintain such insurance is grounds for termination of this agreement, and you are solely responsible for any damages that occur to your golf cart, regardless of the cause of such damage. You hereby waive any and all claims against the City whether arising out of negligent or willful actions or the failure to act, including the City's own negligence, to the maximum extent permitted by law. You acknowledge that the City of Owensville provides no insurance on your cart. As a condition of your cart storage and use of your cart on Owensville Golf Course, you agree to indemnify, defend, and hold the City of Owensville harmless (including its officers, agents, elected and appointed officials, employees and representatives) from and against any personal injury or property damage resulting from the use of your cart or storage of your cart or storage of your cart. In the event of any legal proceeding resulting from the use or storage of your cart, if the City is a prevailing party in such litigation you agree to pay the City's reasonable attorneys' fees and costs of litigation.

2. Storage spaces are non-transferable; only the golf cart(s) and golf equipment on record may occupy the leased space. The storage of any items other than the golf cart(s) is grounds for immediate termination of the lease, in the City's sole and absolute discretion. Copy of key or code must be kept on file in clubhouse.
3. Leased space is not to be used for storage of any other personal items.
4. The lessee accepts that they may be sharing a shed and accepts responsibility of maintaining a neat, orderly area and provide adequate access for the shared tenant.
5. The lessee accepts that the City of Owensville and Owensville Golf Course are not responsible for lost, misplaced, damaged or stolen items or golf carts.
6. The City of Owensville has the right in its sole and absolute discretion to refuse to lease space in the shed, and may terminate any agreement immediately upon any breach by the Lessee.

I have read and agree to abide by the rules and regulations as set forth in this agreement. I understand that violation(s) may result in this agreement being terminated, in the sole and absolute discretion of the lessor, and the removal of my cart from storage. No refunds will be given for loss of storage or use privileges. Your submission of the completed fees and forms constitutes acceptance of the above terms and agreement.
