- 5. Discussed impact of beaches and parking turnouts closer on business. Several properties experienced cancellations. Refunds were issued to all cancellations due to closures. Members recommended the following:
  - A. Better coordination and outreach prior to beach closures
  - B. Close areas on a regional basis and not just Pacific Grove. It was noted that Pacific Grove was the only city to close for 17 days in a row.

- 7. Discussed State proposition 15 the split roll tax measure that will increase property taxes to market rate. HID members urged to oppose the proposition

  - C. Asilomar Conference Grounds
  - D. Future events such as holiday celebrations as well as AT&T....
  - E. Monterey Bay Aquarium
- 9. Mr. Amrish Patel reported on behalf of the Monterey county Convention & Visitors Bureau
- 10. Reviewed the 2020-2021 forecast. Most reported 45 to 50% occupancy that dropped to 30% as a result of the fires. Asilomar Conference Grounds is not likely to host major groups or conferences until April of 2021.
