1. All pages of the application must be completed in full
2. Parties only on Saturday, Sunday or Holidays
3. Parties during Daylight Hours **ONLY** INITIAL: \_\_\_\_\_
4. Petition **MUST** be signed by **ALL** homeowners within the Block Party Designation
5. Sketch of area to be closed off and alternate route for traffic
6. **Removal and cleaning of all party debris will be the responsibility of the Chairperson** INITIAL: \_\_\_\_\_
7. **All Township Ordinances must be adhered to, such as open burning, noise, littering, etc.** INITIAL: \_\_\_\_\_
8. **All state laws must be obeyed, such as alcohol consumption, fireworks, etc.** INITIAL: \_\_\_\_\_
9. Any violations of the above will be strictly enforced by the Piscataway Police Department
10. Any violations of the above will be cause for denial of any future applications

### Barricades:

1. Barricades will be picked up and dropped off at Police Headquarters coordinated through the Traffic Safety Section
2. Chairperson is responsible for picking up and returning the barricades the day after the party.
3. Barricades are to be erected at both ends of the street used for the block party, provisions for emergency vehicles must be provided.
