**The Container shall be utilized by the Customer only for the disposal of bulky waste as approved by the City of Plainfield and in accordance with applicable laws (Permitted Uses).**

#### Exclusions of Waste:

We **DO NOT** accept Hazardous waste, chemical products, oil filters, herbicides & pesticides, radioactive material, solvents, paint (except completely dried latex paint cans, no liquids), other flammable liquids, aerosol cans, propane tanks, motor oil, transmission oil/lubricating/hydraulic oil/oil filters, contaminated oils (mixed with solvents, gasoline, etc.), anti-freeze, petroleum-contaminated soil/lead paint chips, tires, batteries, computers, monitors, televisions, fluorescent tubes, medical waste, asbestos, animals, barrels, all liquids, flammable, toxic, and/or hazardous material, thinners, lacquers, asbestos, infectious waste, contaminated soils, fuels, inks, resins, car batteries, food wastes, adhesives or industrial drums, or "Special" waste, as defined by applicable Local, State and Federal laws or regulations.

**Deposit: \$305 for drop & pull plus the 1st tonnage for 7-day rental. Additional Tonnage billed at \$120/ton.**

#### Container Drop/Pull Fee and Rental Fee:

Customers are allowed to keep Container(s) for a maximum of seven days. Customers will be charged an additional \$15 per day for each additional day after the maximum. The customer is only allowed to keep the container for a maximum of three additional days. After three additional days the customer is required to return the container. If the customer is still in need of a container, a new rental will commence. In addition, weight in excess of one ton will be charged at \$120 per ton. This additional amount will be charged to the credit card on file, without any notice, on the return date of the container. All customers are required to keep a credit card on file so that additional tonnage can be paid for, if applicable.

#### Indemnification:

The Customer covenants and agrees, at its sole cost and expense, to pay and to indemnify, protect, defend, and hold the City of Plainfield harmless from and against all liability, losses, damages, demands, costs, claims, actions, or expenses (including attorneys' fees, disbursements, and court costs) of every kind, character and nature arising out of, resulting from or in any way connected with: the placement of the container on the Premises by the City of Plainfield in the ordinary and commercially reasonable course of such placement, and any incidental damage to the Premises or the surfaces of the Premises that may result from such placement, (whether dirt, lawn, gravel, millstone, asphalt otherwise); and any damages of any kind which may be sustained by the City of Plainfield as the result of the Customer's disposal of bulky waste in the Container which is in violation of the Permitted Uses for the disposal of such waste. The Customer shall not be responsible for any negligent act or omission on the part of the City of Plainfield in connection with the Container other than the commercially reasonable placement of the Container on the Premises.
