Individuals accessing the meetings by telephone will be capable of making a public comment at the appropriate times during the meeting by dialing *9 on their telephone and waiting for the host to unmute them.

Please contact the Board Secretary at least two (2) days in advance of a meeting if you need assistance in order to access the virtual meeting.

Any person or persons wishing to submit written public comment concerning an application or any other matter may do so by written letter or electronic mail submitted to the Board Secretary at least two (2) days prior to the virtual meeting date at which the Board will consider the application or accept general public comment. Any written public comment submitted by written letter or electronic mail will be read



aloud and addressed during the public comment portion of the hearing on the application or during the general public comment portion of the meeting in a manner audible to all meeting participants and the public.

It is requested that anyone who anticipates undertaking cross-examination, introducing evidence and/or making public comment on any application advise the Board Secretary by email or phone in advance of the virtual meeting date. Please supply your name, address and the telephone number at which you may be reached on the night of the meeting in the event that you do not have the ability to access the meeting remotely by computer. The purpose of this notification is to ensure that any additional documents to be identified or referenced at the virtual meeting can be available for review by all participants and members of the public. Nothing in this paragraph shall limit or block the ability of any member of the public to make inquiries; or offer comment or opinion on any application based upon the testimony and exhibits proffered by an applicant at a virtual meeting.

Formal action will be taken at the virtual meetings.
