APPLICATION FOR WETLANDS AGENT APPROVAL**

The Plainfield Inland Wetlands Agent has been authorized to approve and/or extend applications for activities in the Upland Review Area when the agent finds that the conduct of such activity would result in no greater than a minimal impact on any wetland or watercourse. If the agent believes that the proposed activity may have a greater than minimal impact on the wetland or watercourse, the application is referred to the Inland Wetlands and Watercourses Commission for action.

Along with a completed application and \$160.00 application fee, the applicant shall submit a site plan showing existing and proposed conditions in relation to wetlands and watercourses and proposed erosion and sediment control measures.

The applicant must certify whether:

- a. Any portion of the property on which the regulated activity is proposed is located within 500 feet of the boundary of an adjoining municipality.
- b. A significant portion of the traffic to the completed project on the site will use streets within the adjoining municipality to enter and exit the site.
- c. A significant portion of the sewer and water drainage from the project site will flow through and significantly impact the sewage or drainage system within the adjoining municipality; or
- d. Water run-off from the improved site will impact the streets or other municipal or private property within the adjoining municipality.

If any portion of the wetland or watercourse is located within 500 feet of the boundary of the adjoining municipality, the applicant must give written notice to the Wetland Agency of the adjoining municipality in accordance with Section 8.2 of the Inland Wetlands and Watercourses Regulations.

When an application is filed to conduct or cause to be conducted a regulated activity upon an inland wetland or watercourse, any portion of which is within the watershed of a water company as defined in CGS 16-1, as amended, the applicant shall provide written notice of the application in accordance with section 8.4 of the Inland Wetland and Watercourses Regulations.

Applicant Certification: The information provided in this application and the accompanying materials is true and accurate to the best of my knowledge. I am aware of the penalties for obtaining a permit through deception, inaccurate or misleading information. I hereby authorize the Inland Wetland and Watercourses Commission and its agents to inspect the subject property, at reasonable times, both before and after a formal decision is made and during the term of the permit.
