- All employees shall submit colored photocopies of the following documents at the time of their application:
 - Current driver's license;
 - One (1) "ORIGINAL" current passport size photograph. NO CROPPING of regular size photographs
 - All employees are also required submit to a state and national criminal history check and complete the employee application. His/her fingerprints must be taken at the Plainfield Police Department only. The cost of the background investigation is **\$87.00**. This fee must be paid only with a money order or bank check. In the event the employee is denied, this fee is non-refundable.
 - All employees of a licensed pawnbroker, secondhand dealer, or precious metals, gemstone, or coins dealer are required to follow policies of the Plainfield Police Department and shall comply with all regulations and requirements containing in the Connecticut General Statutes.
- All employees are also required to submit to a state and national criminal history check and complete the employee application. **His/her fingerprints must be taken at the Plainfield Police Department only.** The cost of the background investigation is **\$87.00**. This fee **must be paid only with a money order or bank check.** In the event the employee is denied, this fee is non-refundable.
 - All employees of a license pawnbroker, secondhand dealer, or precious metals, gemstone, or coins dealer, are required to follow policies of the Plainfield Police Department and shall comply with all regulations and requirements containing in the Connecticut General Statutes.
