  - 3. Winter Market As of March 19, 2021, the state restrictions regarding events will be lifted and an outdoor event can accommodate 200 people, which would include vendors. Kevin Cunningham approves of an outdoor market so long as the commission remains Covid compliant. Because the event has been shifted to May, it did create conflicts for some of the traditional agriculture vendors who have already made commitments to traditional famers markets that take place on Saturdays. At this point, we have eight confirmed vendors. Sherry requests that commission members send vendor ideas to her via email. A decision will be made at the March meeting whether there are enough vendors to hold the market. A discussion took place regarding non-profit vendors. While there will be no fee for an outdoor site, there will be costs associated with additional portable

bathroom rentals, hand sanitizer and advertising. The commission agreed that spots would be \$20.
