American Chestnut Foundation

W. Cwynar mentioned he has been unable to check on the Plainfield Forest Management Area. He also stated that upcoming month of September is good time to search for any chestnuts that might be on the tree that has been producing for the last two years, and the plan is to get out there during that time.

M. Doyle mentioned scoping out the new Open Space property for American Chestnut trees for conservation purposes.

Open Space Project

W. Cwynar Thanked Adrian Paulsen for outstanding work he accomplished putting together a power point presentation for the Special Town Meeting that was held on Wednesday August 11th. The agenda was to approve spending open space funds to acquire 2 parcels of land on Kate Downing Road that would create access to 139.2 acres of land that is currently land locked and Town owned. Adrian hosted the power point which highlighted the details the acquisitions, and also the results from the open space survey that solidified support from Plainfield residents. W. Cwynar also spoke on behalf of the commission during that meeting. K. Cunningham moderated the meeting and a motion was made for a vote to approve the spending. The motion overwhelmingly passed.

- W. Cwynar mentioned there will be about ~\$300,000 left in the open space fund, after the 2 new land acquisitions, that were recently approved, are finalized.
- S. Hall mentioned it would be good to get an annual statement on the open space account.
- S. Weilk mentioned there may be a grant available to fund some of the progress on the the Open Space Project. S. Weilk mentioned it would be good to check in to see the progress on the project for the next meeting. S. Weilk mentioned the open space is protected by the Deep and mentioned we should reach out them to find out what kind of funding is available to develop the property for public access. A. Paulson mentioned it would be nice to create an open field next to the parking lot near the property and also suggested giving the space a name.

Other Business

W. Cwynar mentioned he submitted the Walktober form for October 2nd. Calendars will be out in early September. The Commission will be planning on some trail maintenance and preparation for the event, in September.
