Bidders may also deliver Bids to the drop-box located at the front of the building located on 106 Brown Avenue, Prospect Park New Jersey up until Thursday, February 1st, 2024 at 11:00 AM. Bidders are reminded that proposals shall be enclosed in a sealed opaque envelope and the outside of the envelope shall bear the name, address and email address of the bidder as well as the indication, "HOFSTRA PARK SOCCER FIELD NETTING BID". It is bidder's responsibility to ensure that bid is received on time. Neither the Borough, nor the Engineer will assume any responsibility for bids mismailed, misdelivered, or misdirected.

Each bid must be made upon the prescribed forms, furnished with the Contract Drawings and Specifications, Including the non-collusion affidavit and ownership statement compliance form and must be accompanied by a bid security in the form of a certified check, cashier's check, or Bid Bond of not less than ten (10%) percent of the amount bid and, not to exceed \$20,000.00. Such checks and Bonds shall be drawn to the order of the Borough of Prospect Park and will be held as a Guarantee that in the event the Bid is accepted and a Contract awarded to the bidder, the Contract shall be duly executed and its performance properly secured. In default thereof, the bid security will be forfeited to the aforesaid Owner as liquidated damages.

Bids shall also include a Consent of Surety obligating the issuing surety to provide the bidder, if awarded a contract for the Project, with performance and payment bonds as required by the Project Specifications. The successful bidder shall furnish and deliver to the Owner a performance bond, in the amount of 100 percent of the accepted bid amount as security for the faithful performance of the Contract.

Bidders are required to comply with the requirements of Mandatory Equal Employment Opportunity Language N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27

All corporations and partnerships must comply with Chapter 33, of the P.L. of 1977, regarding disclosure of partners and stockholders.

All bids shall be irrevocable, not subject to withdrawal and shall stand available for a period of sixty (60) days except as may be permitted by N.J.S.A. 40A:11-23.3.

The Owner reserves the right to reject any and all bids, to waive informalities or Irregularities in the bids received as permitted by law, and to accept the bid from the lowest responsible bidder.
